[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 25, 2017, approximately 0230, I responded to a call at (Coyote Ugly Saloon) 100 Harbor Bd, (Destin FL) in regarding a fight in progress involving six people. The individuals were fighting in front of the business in the parking lot disturbing the peace. Upon arrival, the suspects fled upon sight of law enforcement. One male suspect (Joshua Alexander) stopped running and was detained. Stephen Brown continued to run and jumped into the harbor when confronted by law enforcement. Stephen hid under the dock and the surrounding boats. Stephen then climbed up onto the dock and fled in the sight of me. Stephen refused to comply with verbal commands to stop and continued to run away from me. I repeatedly made commands to stop and deployed my Taser unsuccessfully. Stephen jumped back into the harbor and swam across the Destin harbor to Norreigo Point and fled on foot again. Another deputy went to Norriego Point in attempt to get ahead of Stephen and chased him into a parking garage for a condo complex. When confronted Stephen

physically resisted the deputy and even put the deputy in a "bear hug" to avoid being detained, but was taken into the custody. Staff members on scene for the business identified Stephen as an active participant in the earlier fight.

By participating in a fight in public causing a disturbance, refusing to listen to verbal commands from deputies and fleeing on foot and by swimming in the harbor and placing a deputy in a "bear hug", Stephen Treaver Brown acted in violation of F.S.S. 870.01.1 Affray, F.S.S. 843.02 Resisting Officer without Violence and F.S.S. 784.072b Battery on a LEO. This incident occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
