[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 26th, 2016 I initiated an investigation pertaining to allegations involving the suspect, Daniel Stephen Stark, sexually battering the then approximately eight (8) year old [REDACTED] It was reported by [REDACTED] mother, [REDACTED] that she was advised of the abuse by her adult son, [REDACTED] who found out about the abuse via third party. [REDACTED] stated that her daughter told her Daniel Stark "molested" her and that she believed it occurred a year or so prior to this report. [REDACTED] stated that she believed the incidents occurred during the 2012 and 2013 time frame because that was when her family had contact with Daniel Stark [REDACTED]

[REDACTED] stated that when her daughter told her she was "molested" she also told her that Daniel Stark put his penis inside her. [REDACTED] believed that the sexual battery occurred at the 1309 Greenacres Blvd address (Okaloosa County), where D. Stark lived.
