[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On March 6, 2017, a warrant was issued for the DEFENDANT/Trenton Zackery O'MARA for the offense of battery by strangulation and false imprisonment. This warrant was signed by Judge Maney.

On April 12, 2017, Investigator Joseph Milonas with the Okaloosa County Sheriff's Office Fugitive Warrants Unit observed the DEFENDANT exit his residence and enter a red 2009 Pontiac Solstice convertible, bearing Florida

Registration 473RWX. The DEFENDANT drove away from his residence and Investigator Milonas followed the DEFENDANT until marked Okaloosa County Sheriff's Office Vehicles could assist Investigator Milonas with a traffic stop. Once this was accomplished, Investigator Milonas attempted a traffic stop on Roberts Boulevard and Lewis Turner Boulevard. Investigator Milonas activated his police blue lights to effect the traffic stop. Once the police lights were activated, the DEFENDANT accelerated down Tanager Road actively fleeing Investigator Milonas and other patrol Deputies in marked police vehicles while lights and sirens were activated.

The DEFENDANT continued to flee at high speeds through residential zones, running numerous stop signs. The time of day was early afternoon and the roads contained moving vehicles and pedestrians who at several times were observed by Investigator Milonas moving quickly away from the roadway as the speeding vehicle approached them. At one point, the DEFENDANT caused property damage by driving through a pole in the yard of a residence located at the intersection Schneider Drive and Meadow Lane.

The vehicle pursuit lasted approximately five (5) minutes and covered approximately 3.4 miles in length while lights and sirens were activated. The vehicle pursuit ended at the intersection of Meadow Lane and Green Acres Boulevard in Fort Walton Beach within Okaloosa County where the DEFENDANT was taken into custody without further incident.

Post Miranda, the DEFENDANT admitted to fleeing from the Sheriff's Office because of his warrant and that he did not want to go jail.

Based on the information provided, Investigator Milonas has reason to believe and does believe Trenton Zackery O'MARA did commit the offense of fleeing and attempting to elude a law enforcement officer by willfully fleeing law enforcement officers in an authorized insignia displayed on the vehicles, with sirens and lights activated, while driving at high speeds and in a manner which demonstrated a wanton disregard for the safety of persons or property. This is in violation of F.S.S. 316.1935.3a. This offense did occur within Okaloosa County, Florida.
