[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On April 18, 2017, the Okaloosa County Sheriff's Office responded to a shots fired call located at 2358 Susan Drive, Crestview, Okaloosa County, Florida. Prior to deputies' arrival at the residence, OCSO communications received a total of 3 phone calls advising of a disturbance, then hearing a gunshot.

A neighbor/witness advised OCSO communications he observed a black male shoot another black male then enter the residence located at 2358 Susan Drive, Crestview, FL. He observed the victim laying in the roadway, who was loaded into a brown BMW sport utility vehicle and be driven away.

Investigator Douglas Schwall responded to the North Okaloosa Medical Center where the victim, Charles Booker, was being treated for a single gunshot wound to his left leg. The victim provided a sworn verbal statement attesting to the following information: He advised his sister, Georgiana Williams and her fiancé, Tyshaun Tarver reside at 2358 Susan Drive and he has being staying with them off and on for approximately one month. On today's date, the victim became involved in a verbal altercation with the Defendant, Tyshaun Tarver, while at the residence. The victim stated the Defendant produced a black semi-automatic handgun during the altercation inside the residence but he was able to disarm him by knocking the firearm out of his hand. The victim then gathered his belongings, loaded them into his sister's brown BMW sport utility vehicle, and entered the passenger's side of the vehicle. At this time, the Defendant exited the residence with a .22 caliber rifle and made his way to the passenger side of the vehicle pointing the firearm directly at the victim. The victim grabbed the barrel of the firearm through the open vehicle window and began fighting with the Defendant over the weapon. The altercation ensued throughout the yard of the residence until the victim pulled the mailbox from the ground and used the post to defend himself against the Defendant who was swinging the rifle at him like a baseball bat.

The Defendant removed himself from the physical altercation and entered the residence leaving the victim on the porch. The Defendant exited the residence approximately 30 seconds later with the black semi-automatic handgun. The Defendant then pointed the firearm at the victim, advised him he was going to shoot him, and then discharged the weapon. The round struck the victim in his left thigh area and exited his left hamstring area. According to the victim, the Defendant then re-entered the residence with the firearm leaving the victim on the ground. The victim was transported to the North Okaloosa Medical Center by his sister, Georgiana Williams, and two other friends.

Post Miranda, the Defendant admitted to being in a verbal altercation with the victim, however, he denied any involvement in discharging the firearm and was adamant that the victim shot himself with the firearm. The Defendant denied the ownership of any firearms or ammunition due to the fact that he is a convicted felon.

The victim's clothing was collected and examined. During the examination of the clothing, it appeared the entrance of the bullet was on the exterior of the victim's shorts which is not consistent with a firearm being discharged from inside the victim's pocket.

Your Affiant has reason to believe and does believe the Defendant, Tyshaun Tarver violated Florida State Statute 784.045 (1a2), Aggravated Battery with a firearm. This offense occurred in Okaloosa County, Florida where I am a full time law enforcement officer.
