#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

The Defendant was moving his right hand in a vulgar manner, which he was believed to be masturbating, and immediately stopped upon sight of your Affiant. He was standing in the driveway of the aforementioned residence next to a parked Jeep with a bottle of wine on the hood. During the initial contact, the Defendant stood behind the trash can and there were no clothes observed in the immediate area.

Post-Miranda, the Defendant denied masturbating or being naked and referred to the victim in several derogatory remarks.
