[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 04/02/2017, the Defendant, Bobby Phillip Hyde, was involved in an Indecent Exposure complaint outside of his residence at 2195 Sapphire Court, Fort Walton Beach, Florida.

On this date, per a sworn Affidavit of Complaint, the Defendant was outside his residence and was completely naked. He was moving his hand back and forth and down towards his abdomen while facing the victim's residence as the victim was outside. The Defendant also put his hands over his head to stretch. The victim's residence was located [REDACTED] and the victim was offended by the Defendant's actions.

Upon arrival and visual contact with the Defendant, the Defendant was observed to be naked as he leaned over a trash can. The Defendant was moving his right hand in a vulgar manner, which he was believed to be masturbating, and immediately stopped upon sight of your Affiant. He was standing in the driveway of the aforementioned residence next to a parked Jeep with a bottle of wine on the hood. During the initial contact, the Defendant stood behind the trash can and there were no clothes observed in the immediate area.

Post-Miranda, the Defendant denied masturbating or being naked and referred to the victim in several derogatory remarks.
