[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 5-9-17, I was dispatched to investigate a report of moving vehicles being struck with rocks, in the area of 3041 West Hwy 98, Mary Esther, FL. I contacted Maria Zielinski/Victim, Lorenzo Garcia/Victim, Nikole Garcia/Witness, and Kevin Knauss/Suspect

Zielinski stated she was traveling east on Hwy 98 at around 55 mph. She observed a white male on the side of the road looking in her direction. Zielinski then saw the man throw an object she believed was a rock, smashing her windshield. Zielinski was shaking and said she almost crashed.

N. Garcia was traveling east on Hwy 98 at around 55 mph. She observed a white male on the side of the road, looking in her direction. N. Garcia then saw the man throw an object, she believed was a rock, smashing the windshield.

L. Garcia stated he was in the passenger seat while N. Garcia was driving. Suddenly, something struck his windshield. He then observed a white male on the side of the road looking in his direction.

Knauss/Suspect was about two hundred yards from the victim's vehicles upon my arrival. Both victims and the witness, said that he was the male who committed the crime. They had never lost sight of him.
