

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On July 16, 2017, your Affiant responded to 400 Ed Street, Fort Walton Beach, in reference to a complaint of a burglary and theft.

Upon arrival, your Affiant made contact with the complainant (Defendant) David L. Blackmon who identified himself as a drug dealer. Blackmon stated someone entered his vehicle and stole \$50.00 cash and about one-quarter of an ounce of cocaine off the center console. While Blackmon was showing your Affiant the area where the items were stolen, your Affiant observed a plastic baggie containing suspected cocaine on the center console.

After the burglary/theft investigation was complete, your Affiant advised Blackmon of his Miranda rights. Black asked if I knew the cocaine was there, why did I let him keep talking.

Your Affiant also located a "crack" pipe on the floorboard of the vehicle by the driver's door and seat and a "crack" rock was located on the center console by the baggie of cocaine.

While attempting to place hand restraints on Blackmon, he refused to follow commands. Cpl. Sterling Islinger and your Affiant had to physically turn Blackmon around and place Blackmon's hands behind his back. At that time your Affiant was able to place hand restraints on Blackmon.

The suspected cocaine was found to weigh 1 gram and did field-test positive. The "crack" cocaine was found to weigh less than 1 gram and did field test positive. The residue in the "crack" pipe also field-tested positive for cocaine.

Based on the aforementioned information, your Affiant has reason to believe the Defendant, David L. Blackmon, did violate F.S.S. 893.13(6a) Possession of Cocaine, F.S.S. 893.147 Possession of Drug Paraphernalia, and F.S.S. 843.02 Resisting Arrest Without Violence. These offenses did occur in Okaloosa County, Florida.
