[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 7/17/2017, I responded to Best Buy located on 34940 Emerald Coast Pkwy, Destin, Florida in reference to a theft involving Kelly Patrick HURLEY and Jennifer Erin GILBERT.

HURLEY was seen on video surveillance selecting merchandise, opening it with a box cutter, and concealing the items on his person. HURLEY concealed a bluetooth speaker valued at \$39.99, a pair of bluetooth headphones valued at \$99.99, and a portable charging device valued at \$49.99. Hurley was then observed as he passed all points of sale without making any attempts to render payment. HURLEY was confronted by employees where he pulled the stolen headphones from his pocket and handed them to employees. HURLEY then attempted to push passed them to leave the store. A short struggle ensued and HURLEY pushed employee William Stephen NOBLES. During the struggle, HURLEY brandished the box cutter and made a remark that he was not going to jail tonight. These actions caused NOBLES to fear for his life and caused him to take HURLEY to the ground to protect himself. HURLEY was let go upon the arrival of deputies. HURLEY was then taken into custody.

A search of HURLEY's pockets revealed a box cutter and a pair of pliers along with the other stolen merchandise, consisting of the portable charging device and the bluetooth speaker. The box cutter and the pliers are common tools used for removing anti-theft devices and/or packaging from merchandise.

The total amount for the stolen merchandise was \$189.97.

A criminal history was conducted on HURLEY, which revealed in excess of three prior convictions of larceny in Okaloosa County, Florida.

Based on my investigation, I have reason to believe the defendant, Kelly Patrick HURLEY violated F.S.S. 812.014(3c) Retail Theft 3rd or subsequent conviction, F.S.S. 812.015(6) Resisting a Retail Merchant, F.S.S. 812.015(7)

On 7/17/2017, I responded to Best Buy located on 34940 Emerald Coast Pkwy, Destin, Florida in reference to a theft involving Jennifer Erin GILBERT and Kelly Patrick HURLEY.

\$39.99, a pair of bluetooth headphones \$99.99, and a portable charging device \$49.99, in his pockets and passed all points of sale, without making any attempts to render proper payment. While HURLEY removed and concealed merchandise, surveillance video showed GILBERT acting as a look-out and blocking HURLEY from the view of nearby employees. GILBERT left the store while HURLEY was confronted by employees.

GILBERT was located and detained in the parking lot by law enforcement. Post-Miranda, GILBERT admitted HURLEY was talking about stealing from Best Buy in the days and hours previous to this incident. GILBERT knowingly went to Best Buy with HURLEY knowing he intended on stealing merchandise from the business.

Based on my investigation, I have reason to believe the defendant, Jennifer Erin GILBERT, committed retail theft by working in concert with Kelly P. Hurley while he stole merchandise from Best Buy, violating Florida State Statute F.S.S. 812.014(2e) Retail Theft over \$100.00 less than \$300.00. This incident occurred in Okaloosa county, Florida where I am a sworn law enforcement officer.
