

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 7/21/2017, I responded to 704 NW Doyce Dr., Ft. Walton Beach, FL in reference to a family disturbance. Upon arrival, I attempted to make contact at 704 NW Doyce Dr; however no one answered the door.

A short time later, the Victim, Virginia Boyd responded to the scene. The victim reported in her sworn written and verbal affidavit that on 7/21/2017, She posted a note on Michael Boyd's, later identified as the defendant's, bedroom door advising he had to move out. The victim and defendant are siblings, related by blood, and live together as a family unit.

The victim said an argument between the two ensued over the victim wanting the defendant to move out. The victim said during the argument, the defendant ran towards her and produced a small handgun, and began pointing it at her head. The victim said the defendant told her "bitch I'll kill you" while menacing her with the handgun. The victim said she was scared, and grabbed the barrel of the handgun to push it away from her. However, the defendant kept trying to push the handgun back towards her. After a few moments of struggling with the handgun, the defendant stepped back and moved into the kitchen, The victim grabbed her, young child, and fled the residence for safety.

Contact with the defendant was attempted prior to the victims affidavit; however, after numerous lawful

commands via public announcement (PA) the defendant remained within his residence. While attempting contact with the defendant, the second victim, Christina D. Stephens called the Okaloosa County Sheriffs Office Communications division.

Stephens reported she was inside the residence located at 704 NW Doyce Dr, and was eventually patched through to my cell phone. I spoke to Stephens, and asked if she would exit the house. Stephens stated to me that she opened the door to her bedroom to leave, when the defendant told her " if you got outside I'll fuck you up". I was on the phone with Stephens during this time; however I did not hear the defendants statement.

Stephens was eventually able to exit the residence. During which time she completed a sworn written affidavit. Stephens wrote in her affidavit the defendant told her " I'll kick your ass if you go outside." Stephens said she feared for her safety, and believed the defendant meant he would harm her.

Based on these statements, I have reason to and do believe the defendant Michael K. Boyd violated F.S.S 784.021.1a - Aggravated Assault- (DOMV), and F.S.S 784.11 Assault. This incident occurred in Okaloosa County, FL where I am a sworn law enforcement officer.
