suite. Deputy Morton collected the victim's bloody clothing and other items that were found in his clothing. Upon my arrival, I collected the clothing from Deputy Morton. Later, I gave Crime Scene Investigator Lisa Hughey the evidence collected from the victim. After I was relieved by Investigator Siren I went to 841 Blvd De Lorleans, Mary Ester, Florida.
Upon my arrival, I was met by Lester Wolthers who informed me official statements were taken from Phillip Pulley, Barbara Pulley, and Ronald Pulley signed a Consent to search the house and Phillip Pulley signed a consent to search of his bedroom. This was where the shooting occurred.
During a search of a bedroom belonging to the Defendant, Phillip Pulley, the following items were located:
-A plastic baggy containing suspected marijuana. The marijuana was field tested and rendered a presumptive positive response for the presence of THC. Approximately 20 grams of marijuana was located along with two digital gram scales and packaging material which is indicative of narcotics distribution.
- There were multiple digital scales found in the same area as two bindles of heroin and vacuum packed bag of Marijuana.
-A plastic baggy containing suspected heroin was field tested and the substance rendered a presumptive positive response for the presence of heroin. The total gross weight of the heroin was 13 grams.
-A box was discovered in the top dresser drawer with two rounds of 9 mm ammunition. After querying Phillip Pulley's criminal history it showed 12 felony charges with 9 felony convictions. Pulley was a convicted felon and was prohibited from possessing a firearm or ammunition.
-A black Taurus 45 caliber semi-automatic handgun magazine which contained 45 ACP ammunition.
Based upon your Affiant's investigation, there is probable cause to believe the Defendant, Phillip Pulley, did violate F.S.S. 893.13(1a2) Distribution of Marijuana, F.S.S. 893.135.1c1 Trafficking in Heroin and F.S.S. 790.23 (1a) Possession of a Firearm of Ammunition by a Convicted Felon. These offenses are contrary to law, as such case provided, and against the peace and dignity of the State of Florida.
