[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On the morning of 08/13/17, I initiated a traffic stop on a white Chevy Cobalt, displaying Mississippi License Plate FNB830, for swerving within a lane.

Upon making contact with the driver of the vehicle I smelled the odor of marijuana emitting from the vehicle.

The defendant, Paige Elise Chaffins, was a passenger in the vehicle at the time of the stop and was detained.

During a search of the vehicle, a brown purse was located, which contained two bags of suspected marijuana, weighing a total of 23 grams. The marijuana was field tested and yielded a presumptive positive for the presence of THC (marijuana.) Additional plastic baggies containing 22 grams of Zanax (Alprazolam,) a schedule IV narcotic, and 9 grams of MDMA, a schedule I narcotic, were located inside the purse. Additionally a sum of cash, \$348.00 was found in the purse with the narcotics. The cash was in a "street fold," which based on my training and experience, is how narcotics dealers carry their monies.

Post Miranda the defendant admitted to being the owner of the purse and its contents. She identified each substance and advised the money was the profits from selling the narcotics over the past couple of days.

Based upon my investigation, the evidence present, and the defendant's admission, I have reason to believe, and do believe, the defendant, Paige Chaffins, committed the offenses of Possession of Paraphernalia, which is in violation of F.S.S. 893.147(1,) Possession With Intent to Distribute Marijuana, which is in violation of F.S.S. 893.13 (1a1,) Possession With Intent to Distribute Zanax (Alprazolam,) which is in violation of F.S.S. 893.13 (1a,) and possession with intent to Distribute MDMA, which is in violation of F.S.S. 893.13 (1a1.) These offenses did occur in Okaloosa County, Ft. Walton Beach, Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On the morning of 08/13/17, I initiated a traffic stop on a white Chevy Cobalt, displaying Mississippi License Plate FNB830, for swerving within a lane.

Upon making contact with the driver of the vehicle I smelled the odor of marijuana emitting from the vehicle.

The defendant, Elijah Lenoir, was a passenger in the vehicle at the time of the stop and was detained.

During a search of the vehicle, a "Louis Vuitton" satchel was located, which contained three sperate baggies each containing suspected marijuana, weighing a total of 61 grams. The marijuana was field tested and yielded a presumptive positive for the presence of THC (marijuana.) Additionally, materials consistent with packaging marijuana/narcotics were located in the form of plastic sandwich baggies and a digital scale. There was also a sum of cash, \$415.00 which was found in the satchel with the narcotics. The cash was in a "street fold," which based on my training and experience, is how narcotics dealers carry their monies. A Ruger .22 caliber pistol was also located inside the bag in conjunction with the marijuana, packaging materials, and money.

Post Miranda the defendant invoked his fifth amendment right.

Other occupants in the vehicle, Paige Chaffins, and Lindsey Dampier identified the satchel as belonging to the defendant and advised he entered the vehicle carrying the satchel when they picked him up.

Based upon my investigation, the evidence present, and the defendant's admission, I have reason to believe, and do believe, the defendant, Elijah Lenoir, committed the offenses of Possession of Paraphernalia, which is in violation of F.S.S. 893.147(1,) Possession With Intent to Distribute Marijuana, which is in violation of F.S.S. 893.13 (1a,) and Possession of Firearm in the commission of a felony, which is in violation of F.S.S. 790.07 (1.) These offenses did occur in Okaloosa County, Ft. Walton Beach, Florida.
