[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

I have reason to believe and do believe, on July 31, 2017, in the area of Emerald Coast Parkway @ Kelly Plantation Drive, Destin, FL, the defendant, Austin Richard Hopper, did commit the offense of Aggravated Assault, Possession of Drug Paraphernalia, Possession of Methamphetamine, and Criminal Mischief, to wit;

Upon my arrival, I made contact with the defendant, who was riding his lawn mower away from the victims and witnesses, across Kelly Plantation Drive. The defendant initially said there was no physical contact, but "they" were trying to start a fight with him. The defendant was unable to provide further details. I observed a orange traffic cone wedged under the defendants riding lawn mower, which he said was his companies.

The victims and witnesses were working on the side of Emerald Coast Parkway laying pipe underground. The victim, who was the construction site manager, said as he was sitting in the back hoe tractor, he could feel wind against his face, and noticed the defendant had placed the end of the weed eater in the cabin of the tractor. I spoke to another construction site worker who witnessed that incident and collaborated his statement. The victim stated, shortly after, the Destin Water Users worker arrived on scene after he was advised of the defendant obstructing the construction site.

The Destin Water Users employee explained, he was also threatened with the weed eater, as the defendant lifted it up towards his face as he approached him. The victim said he then backed up, and then called "OCSO." There was also a witness who collaborated this statement, and observed the defendant raise the weed eater to this victim. The victim and witnesses also explained the defendant had ran over two of their orange traffic cones, one of which was observed under the lawn mower.

As D/S D. Williams was patting the defendant down for weapons, he advised me he felt a object that felt like a syringe in the right pant cargo pocket. A syringe with a white crystal residue was located, and the substance tested positive in a presumptive field test for Methamphetamine.

Based on my investigation, observations, and victim and witness statements, I have reason to believe and do believe, the defendant, Austin Richard Hopper, did commit the offense of Aggravated Assault, contrary to Florida Statute 784.021(1)(a), Possession of Drug Paraphernalia, contrary to Florida Statute 893.147(1), Possession of Methamphetamine, contrary to Florida Statute 893.13(6)(a), and Criminal Mischief, contrary to Florida Statute 806.13(1)(b)(1). These offenses occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
