On August 24, 2017, the Okaloosa County Sheriff's Office initiated an investigation into the theft of controlled substances from the Sheriff's Office Evidence Section. As a result of the investigation, it was determined that Evidence Technician Deidra Rezzarday, the DEFENDANT unlawfully removed controlled substances, including but not limited to, Xanax, Ambien, and Clonazepam from the evidence section. These substances were found to be part of past investigations where the items were marked for destruction and stored in the OCSO evidence facilities.

During a post-Miranda interview, Rezzarday admitted to taking controlled substances from the OCSO evidence section. The investigation revealed Rezzarday used OCSO computers to target specific types of prescription medications that were stored in the OCSO evidence facility and marked for destruction. An audit of the OCSO evidence section revealed exhibits that were previously marked for destruction were found to have been removed and/or were missing from the OCSO evidence section.

Search warrants were executed on Rezzarday's personal bags, residence, and vehicle. The search warrants resulted in the recovery of prescription medication that was identified as OCSO evidence previously marked for destruction.

Based upon the aforementioned information, Investigator Branden Findley has probable cause to believe Rezzarday
