[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Tony Wilhelm, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since March 2016. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On 9/2/2017, at 1700 hours, due to six reckless vehicle calls with two callers stating the vehicle hit the guard rail, Deputy Sheriff J. Kimbrill made an investigatory stop on a silver Dodge Ram 1500 bearing Louisiana registration C400895 and driven by TIMOTHY HEBERT. HEBERT was ultimately arrested for Driving Under the Influence and issued Florida Uniform Traffic Citation A89JTOE.

Search incident to arrest, HEBERT was found to be in possession of 13 bars of "xanax" (Benzodiazepine) contained in a metal pill container on his key chain. Within the center console of the vehicle was discovered two more bars of "xanax" and a syringe.
