[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On August 22, 2017, the Okaloosa County Sheriff's Office investigated a shooting incident that occurred at the intersection of Twin Lakes Lane and Airport Road, Destin, Florida. The victim, Tyjuan Lee was shot in the back of the head with a firearm while seated as a passenger inside a moving vehicle. Tyjuan Lee was subsequently transported to Fort Walton Beach Medical Center and a projectile was removed from the right side of his head. Tyjuan Lee later provided a signed/sworn affidavit of complaint indicating he had been shot by an unknown person that was inside a dark colored Jeep Wrangler.

During the course of the investigation, the Defendant, DEVEON MICHAEL YAWN, was identified as a suspect in this case. DEVEON MICHAEL YAWN was identified as an occupant of the dark colored Jeep Wrangler.

During an interview with witness, Skylar Fitzgerald, he provided a signed/sworn written statement indicating while he was driving his vehicle, DEVEON MICHAEL YAWN, was seated in the front passenger seat of his Jeep Wrangler. Skylar Fitzgerald stated DEVEON MICHAEL YAWN pointed a firearm out of the passenger side window of his vehicle and shot a round at a white vehicle that was in front of his vehicle while they were turning at the intersection of Twin Lakes Lane

and Airport Road, Destin, Florida.

During an interview with witness, Zachary O'Brian, he provided a signed/sworn written statement indicating while he was the passenger inside Sklyar Fitzgerald's Jeep, Zachary O'Brian stated DEVEON MICHAEL YAWN, was seated in the front passenger seat of the Jeep Wrangler. Zachary O'Brian stated DEVEON MICHAEL YAWN pointed a firearm out of the passenger side window of the vehicle and shot a white vehicle that was in front of their vehicle.

During a non-custodial interview, DEVEON MICHAEL YAWN, admitted that he had shot a .38 snub nosed pistol out of the window at a moving vehicle at the intersection of Twin Lakes Lane and Airport Road. DEVEON MICHAEL YAWN stated he did not intend to shoot anyone. DEVEON MICHAEL YAWN stated he was shooting at the bottom of the car to scare the occupants of the other vehicle. DEVEON MICHAEL YAWN then pointed out where he had discarded the firearm.

Based upon your Affiant's investigation, there is probable cause to believe the Defendant, DEVEON MICHAEL YAWN, did violate F.S.S. 784.045 (1a2) Aggravated Battery with a Deadly Weapon and F.S.S. 790.19 Shooting a Deadly Missile into a Dwelling, Vehicle, Building, or Aircraft. These offenses are contrary to law, as such case provided, and against the peace and dignity of the State of Florida.
