[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Sunday 10-8-2017 at approximately 1730 hrs. the defendant, Dakota J. Davis, violated F.S.S. 784.045 Aggravated Battery by striking and causing great bodily harm to the victim, James Vires.

James Vires stated in a sworn statement Dakota struck him several times in the face and body. James believes a chicken bone was used, causing him a small puncture to his cheek. James was later treated at North Okaloosa Medical Center and was diagnosed with multiple fractured ribs, pain in the hand and fingers and a contusion to an unspecified part of his head.

Dakota Davis was interviewed and post Miranda advisement admitted to striking James twice with his hand and holding James in a "headlock" for a second suspect to strike him. Dakota denied using an object to strike James with.

Video surveillance of the incident exists and corroborates what James reported.

Based on the above stated facts I have reason to believe and do believe Dakota Davis violated Florida State Statute 784.045 Aggravated Battery. This offense occurred in Okaloosa County where I am a sworn Deputy Sheriff.
