[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Your Affiant's investigation is based on his observations, injuries on the victims, and statements from the victims and witnesses.

The defendant, Marcus Mitchell, [redacted] Crestview, Florida.

[redacted] Marcus is currently on felony probation for aggravated battery (pregnant victim). He has at least two prior convictions of battery. He was convicted of aggravated battery (pregnant victim) in the State of Florida on June 5, 2013; and convicted of domestic violence battery in the State of Nevada on June 1, 2010.

On October 14, 2017, Marcus was intoxicated and standing outside of [redacted]. As they were walking into the house, Marcus grabbed [redacted] and began beating her. He pulled her into [redacted] room, slammed her to the ground, and continued to beat her. Annemarie attempted to intervene due to the severity of the attack. Marcus then turned towards her. He slammed her to the ground, punched her in the nose, and slapped her in the face. She felt blood coming from her nose, so she attempted to call 911. Marcus came after her and took her phone from her. She then fled across the street, and attempted to get help from [redacted]. She knocked on the door and cried for help, but no one came out. She then went to [redacted] Drive. Someone opened the door and she begged them to call the police. Marcus eventually caught up to her and dragged her back inside of the house. Marcus kept Annemarie in the foyer area, shouting at her aggressively until he was confronted by law enforcement. Marcus refused numerous law enforcement orders to step outside or to get on the ground and had to be tased to be taken into custody.

Annemarie told your Affiant of the above incident in recorded verbal interviews and a sworn written statement. [redacted] told your Affiant in recorded verbal interviews that Marcus attacked her and Annemarie when they [redacted]. She said that Marcus took Annemarie's phone.

As a result of the attack, [redacted] suffered a bruise underneath her left eye and complained of hand pain. Annemarie's nose was bleeding, swollen, and believed to be broken. She also has bruises on both of her arms around the area of the tricep, bruises and bumps around her left eye, a red mark on the right portion of her lower back, and a small scrape on her right knee.

Part of the incident was witnessed by [redacted] the residents of [redacted] Twin Oak Drive. In recorded verbal interviews and sworn written statements, [redacted] said that they saw Annemarie running up to their house in obvious fear. She knocked on their door and told them she was being chased. They refused to open the door as they were afraid of Marcus. [redacted] called 911 while [redacted] continued to watch what happened. [redacted] saw Marcus grab Annemarie and drag her inside the residence.

[redacted] the resident of [redacted] Twin Oak Drive, acknowledged that Annemarie came to his house asking for help. He did not see any physical altercation.

Your Affiant was the first responding officer to a report of black male dragging a white female into [redacted]. Your Affiant knew that this was Marcus' residence and knew of his intoxication due to a prior call. Your

Affiant saw Marcus in the foyer aggressively shouting at Annemarie, who was an arm's length away. Marcus refused numerous commands given by your Affiant and had to be tased to be taken into custody.

Your Affiant viewed Marcus' criminal history record and verified Marcus' probation status and prior convictions.

Based on the above information, your Affiant has reason to believe and does believe that the defendant, Marcus Mitchell, violated Florida State Statutes 784: Battery (domestic violence, second or subsequent conviction); 827.03(2c): Child Abuse Without Great Bodily Harm; 914.22(2b): Tampering with a Victim (hinder or prevent the report of a third degree felony); (843.02: Resisting an Officer without Violence; and 948.06(A): Violation of Felony Probation. These offenses occurred in Okaloosa County, where your Affiant is a sworn law enforcement officer.
