[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Deputy Sheriff Brian Powe, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since April 2017. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant previously served as a Deputy Sheriff in and for Bay County, FL, for approximately six years. Your Affiant being duly sworn states as follows:

The defendant, DOUGLAS LEVIN, committed the offense of AGGRAVATED BATTERY to wit:

Between 09/29/2017, and 10/01/2017, the defendant did knowingly and willfully commit the offense of Battery, and in doing so caused great bodily harm to the VICTIM, Taralee Plis. The defendant did so by striking the victim repeatedly in the face causing significant swelling and bruising with lacerations. The victim's eyes were swollen nearly to the point of being closed and the facial area was observed to be swollen and purple. The victim also was observed to have dried blood matted in her hair and caked underneath her fingernails. Closer examination of the victim by medics on scene revealed bruising to the victim's sternum area. The makeshift shelter where this offense occurred was observed to have a large amount of blood splatter on one wall, as well as large stains on cushions where it appears blood had pooled. The victim was transported by ambulance to Fort Walton Beach Medical Center for treatment. The medical staff indicated the victim has likely suffered a broken hand and wrist along with significant facial injuries based upon their initial assessments. The victim identified the the defendant on scene as the person responsible for the injuries observed. The victim was unable to complete a written Affidavit Of Complaint due to her injuries; she was however sworn to her verbal
