[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 13, 2017 at [REDACTED] Destin, FL the defendant, Nathan Cole Robertson, committed battery domestic violence on his mother, Charlette Ashley Schindler and aggravated battery domestic violence on his step-father, Charles Joseph Schindler II.

Charlette stated the defendant was inside the residence playing on the video game console in the living room. Charlette told the defendant she would smash his video game console with a golf club if he did not get off the game and talk to her. The defendant became aggressive and grabbed the golf club Charlette had in her hands. Charlette stated the defendant was pushing her with the golf club in her hands. Charlette stated Charles came into the living room and had a altercation with Nathan. Charlette stated she did not see who struck who.

Charles stated he heard Charlette and the defendant yelling in the living room. Charles came into the living room and observed the defendant pushing Charlette on the couch. Charles stated he grabbed an object and struck the defendant in an effort to get the defendant off Charlette. The defendant grabbed a golf club and struck Charles across the face. Charles stated he was trying to get the defendant out of the house and told the defendant to leave. Charles stated the defendant struck him multiple times and pushed him through the hallway to the front door. At one point Charles stated the defendant stabbed him with an unknown object on the right side of his abdomen. The object caused an abrasion to his skin. Charles stated the fight continued outside the front door as the defendant continued to pushed him

against the corner of the front door and to the side of the brick house. The defendant departed the property with Charles' other son, Noah Robertson.

I visually inspected Charles and observed a 4 to 5 inch abrasion across the right side of his abdomen. Charles had redness to the left side of his face and a small abrasion mark to his left hand index finger knuckle.

The defendant stated he was in the living prior to the argument playing video games and Charlette wanted to talk to him. The defendant stated he was playing a multiplayer game and could not pause the game to speak to Charlette. The defendant stated Charlette became upset as Charlette came into the living room with a golf club and threaten to smash his video game console if he did not stop playing. The defendant stated he grabbed the golf club Charlette was holding and both of them struggled for control of the golf club. The defendant stated Charles came into the living room and struck the defendant with another golf club. The defendant stated he became aggressive towards Charles and struck Charles with the golf club Charlette was holding. The defendant stated he struck Charles with the golf club multiple times until the tip of the golf club broke. The defendant stated he then attempted to stab Charles with the broken end of the golf club. The defendant stated Charles would not let him leave the residence as Charles blocked his path. The defendant stated he pushed Charles multiple times down the hallway until he could exit the front door. The defendant departed the residence with Noah.

Noah stated he was not in the living room when the initial fighting started. Noah stated he attempted to separate Charles and the defendant. Noah stated he departed the residence with the defendant to have the defendant cool off.

Based on my investigation, which included interviews with the victims, defendant, one witness, and my personal observations, I believe Nathan Cole Robertson committed Battery (Domestic Violence) on Charlette Ashley Schindler and Aggravated Battery (Domestic Violence) on Charles Joseph Schindler II which is in violation of Florida State Statute section 784.03.(1)(a)(1) and Florida State Statute 784.045.(2).

This offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
