While on scene, I also smelled an odor emitting from the residence, specifically from the closet located directly under the stair way. The odor was consistent with a decaying body.

A search warrant was obtained and executed for the residence located at 86 10th Avenue, Shalimar, Florida. During the search, a fabricated brick wall was located inside the closet under the stair way. It was apparent that the brick wall was built to conceal the decaying body. Upon removing the bricks and drywall, a large, dark plastic material in the similitude of a tarp was observed. This aforesaid material was shaped in the consistency of an adult body. Likewise, the material was thoroughly duct taped.

Evidence was located inside the residence that corroborates the statements provided by Christian and Gloria that a possible shooting did occur inside the home.

Based on my investigation, verbal statements and evidence located within the residence, I have reason to believe and do believe the defendant, Barbara Wozniak, did commit the offense of Tampering with Evidence in violation of F.S.S. 918.13. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.
