[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07/22/17, deputies responded to the Shell Gas Station, 443 Green Acres, Ft. Walton Beach, FL in reference to an armed robbery. The clerk advised an unknown black male, later identified as DION WINGATE JR., entered the store from the east entryway, wearing a dark hooded sweatshirt, dark pants, and black shoes. The defendant brandished a revolver and demanded the victim open the register and give him the money inside the cash drawer. The clerk gave the defendant approximately \$140.00. The defendant fled the store through the eastern entrance towards Beal Parkway. The

clerk advised the male had entered the store approximately 45 minutes earlier but left without purchasing anything after he saw other customers inside the store. The defendant had told the clerk that he "had left his money at home" before he departed the first time. The clerk informed deputies the defendant possibly lived in the 400 block of Green Acres Road.

Deputy Powe reviewed the surveillance footage and noticed the defendant smoked a cigarette prior to entering the store before the armed robbery. The defendant, dressed in a dark sweatshirt, dark pants, black shoes, and a Tampa Buccaneers hat, discarded the cigarette butt near the handicapped parking spot on the east side of the store. Deputy Powe retrieved the cigarette butt that was later sent to FDLE for analysis.

During a canvass of the area, deputies made contact with the residents of 423 Green Acres Road. The defendant's younger brother advised that he resided there with his brother, DION WINGATE JR., however he was not present at the time. Deputies located a Charter Arms revolver (S/N 82183) on the outside curtilage of 423 Green Acres Road along with a Tampa Bay Buccaneers hat and gray jacket.

On 10/30/17, I received the FDLE lab results identifying a CODIS match to the defendant, DION WINGATE JR.

The defendant was adjudicated guilty of Aggravated Assault with the intent to commit a felony in 2016.

Based on the above information above information the defendant, DION WINGATE JR., violated F.S.S. 812.13 (2a) Armed Robbery and F.S.S. 790.23 (1a) Possession of a firearm by convicted felon. This offense occurred in Okaloosa County, FL where I am a sworn law enforcement officer.
