[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 11/21/17, the Defendant, Andre Lamonte Wells, committed the offense of Criminal Mischief, damage estimated at \$500.00. This is in violation of Florida State Statute 806.13 (1)(b)(2).

On the above mentioned date, the Defendant was walking in the area of Elaine Avenue, Fort Walton Beach, Florida. The Defendant entered the driveway of 203 Elaine Avenue, where a silver 2008 Dodge SUV was properly parked. The Defendant then obtained an unknown object and struck the rear right window, located behind the c pillar, and struck a body of the vehicle just under the window, causing minor damage. The Defendant then departed the scene in an attempt to flee the area.

The Victim, who is the registered owner of the vehicle, happened to be seated in the driver's seat and observed the Defendant cause the damage to her vehicle. The Victim described the Defendant as a black male, wearing a blue sweat shirt, with short "nappy" hair, and dark pants. A Witness on scene advised when he was called by the Victim to come to the residence, he observed a male matching the description of the Defendant in the parking lot of the Props Brewery.

While conducting the investigation, the Fort Walton Beach Police Department called and advised they were out with a male who was possibly involved in the Criminal Mischief at Chilli's Restaurant, located on Mary Esther Boulevard. The Victim was transported to the Chilli's Restaurant for a "show up" in attempt to identified if the male detained was involved. Upon arrival, the Victim positively identified the Defendant as the person who damaged her vehicle. It was later discovered the Defendant was involved in another Criminal Mischief, where the Defendant threw a rock at the front of the Props Brewery, causing damage.

The Defendant was secured in the rear of my patrol vehicle and transported to the Sheriff's Office Booking Facility. While enroute to the Booking Facility the Defendant spontaneously stated he was holding a hammer while he was at 203 Elaine Avenue. The Victim completed a Sworn Affidavit of Complaint in reference to this incident and estimated the damages to be \$500.00.

This incident occurred in Okaloosa County where I am a Sworn Law Enforcement Officer.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 11/21/17, the Defendant, Andre Lamonte Wells, committed the offense of Criminal Mischief, damages estimated at \$2,500.00. This is in violation of Florida State Statute 806.13 (1)(b)(3).

On the above mentioned date, the Defendant entered the parking lot of the Props Brewery, located at 125 Lovejoy Road, Fort Walton Beach, Florida, while holding a rock. The Defendant then utilized the rock to throw at the front window of the establishment. The Defendant picked up the rock and threw it again and struck the metal window frame. The Defendant then picked up the rock a third time and threw it striking the metal frame and metal siding. All three impacts caused moderate damage to the front of the establishment.

A Witness, who was responding to another report of Criminal Mischief involving the Defendant, at 203 Elaine Avenue, observed the Defendant in the parking lot. The Witness was interviewed and advised he observed a male wearing a blue sweat shirt with dark pants with short "nappy" hair, utilize a rock to throw at the front of the establishment. The Witness was then Sworn to his Verbal Statements regarding this incident.

The Defendant had already been located after the Fort Walton Beach Police Department called and advised they were out with a male who was possibly involved in the Criminal Mischief, at Chillis Restaurant, located on Mary Esther Boulevard. During the investigation the Defendant was positively identified as the suspect of the Criminal Mischief that occurred at 203 Elaine Avenue by the Victim of that crime after a "show up" was conducted. The Defendant was advised he was being arrested for the Elaine Avenue Criminal Mischief and secured in the rear of my patrol vehicle. The Defendant was then transported to the Chevron Gas Station, which is located at the intersection of Lovejoy Road and Mary Esther Boulevard for a "show up", regarding the Props Brewery incident. Upon arrival, the Witness was brought over to the Chevron Gas Station and positively identified the Defendant as the suspect to the Props Brewery Criminal Mischief.

After the Defendant was identified as the suspect, he was re-secured in the rear of my patrol vehicle and transported to the Sheriff's Office Booking Facility. The Owner of the establishment completed a Sworn Affidavit of Complaint in reference to this incident and estimated the damages to be \$2,500.00. The incident was caught on surveillance cameras located on the front of the establishment. The surveillance footage revealed the Defendant utilized a rock to strike the establishment three times.

This incident occurred in Okaloosa County where I am a Sworn Law Enforcement Officer.
