[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On the 11/24/17, the defendant, Jonathan Miller did violate F.S.S. - 784.041.2a - Battery - Commit domestic battery by strangulation, F.S.S. 827.03.2c - Cruelty towards child - Abuse child without great bodily harm, and 914.22.1 - Obstructing justice - Tampering in 3rd degree felony proceeding.

During an argument between the defendant, Jonathan Miller Sr. and victim Amanda Miller, the defendant started pushing her in the hallway of the residence. At one point he grabbed her by the throat and choked the victim Amanda Miller. Another victim, [REDACTED] tried to intervene to stop the fight at which time the defendant Jonathan Miller Sr. pushed victim [REDACTED] back causing him to hit the side of the couch with his right hip.

**Both the defendant and victim Amanda Miller then proceeded outside through the back door and into the yard.**

**Victim Amanda Miller attempted to cross the yard in order to go to a neighbors house to call 911. The defendant Jonathan Miller Sr. ran and tackled victim Amanda Miller and sat on her pinning her face down on the ground. In doing this the defendant Jonathan Miller delayed victim Amanda Miller from reporting this incident to law enforcement. The defendant Jonathan Miller started punching victim Amanda Miller in the face and back of the head causing her to start bleeding from her mouth and left ear. While punching victim Amanda Miller, the defendant Jonathan Miller broke her jaw and caused a large contusion on the back, left side of her head. The defendant Jonathan Miller also grabbed the victim Amanda Miller in a vascular neck restraint and kept punching her in the head. While in the vascular neck restrain, the victim Amanda Miller could not breathe and felt like she was going to pass out.**

**The defendant was observed on top of victim Amanda Miller in the yard by law enforcement on arrival.**

**I have reason to believe and do believe the defendant, Jonathan Miller, willfully and deliberately violated F.S.S. - 784.041.2a - Battery - Commit domestic battery by strangulation, F.S.S. 827.03.2c - Cruelty towards child - Abuse child without great bodily harm and 914.22.1 - Obstructing justice - Tampering in 3rd degree felony proceeding.**

**This incident did occur in Okaloosa County where I am a sworn Deputy Sheriff.**
