[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On November 26, 2017 the defendant Roberto Solis II was arrested for burglary. During this arrest the defendant was advised of his Miranda Warning and did not invoke his rights. The defendant was cooperative and answered questions asked of him. During questioning the defendant was asked about a Echo Weed Trimmer he pawned on November 21, 2017. The defendant stated he had forcefully entered into the property of Crestview Wholesale, broke into a

storage area and stole several items.

The victim, William Rogers, was informed of the burglary. A check of the area revealed that an enclosed trailer had been broke into and 8 pieces of lawn equipment was taken with a total value of \$2,382.00

Based on the above stated facts I have reason to believe the defendant Roberto Luis Solis II, committed the crime of Burglary in direct violation of Florida State Statute 810.02(4b), Grand Theft over \$300 less then \$5000 in direct violation of Florida State Statute 812.014(2c1). and False Owner Info Pawn Item less then \$300 in direct violation of Florida State Statute 539.001(8b8a).

This incident occurred in Okaloosa County where I am a sworn law enforcement officer.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Adams, an employee. Brian provided me with a Sworn Affidavit of Complaint.

James Lee Blvd. Crestview, FL in reference to a burglary with force entry. Upon arrival I made contact with Brian

On November 24, 2017 at approximately 8:03 am I was dispatched to Crestview Wholesale, located at 984 W

During the course of the investigation surveillance video from Crestview Wholesale was observed by this deputy. Several photos were taken from the videos and shared with other Law Enforcement Officers. The defendant, Roberto Luis Solis II, was identified. Also during the investigation photos of shoe impressions left by the defendant were collected.

On November 25, 2017 it was discovered a case knife had been pawned at Hub City Pawn Shop in Crestview, FL by witness, Michael Tracy Long. During a sworn recorded interview with Mr. Long, he stated that he pawned the knife after he received it from Roberto Solis. Mr. Long described other items that had been stolen from Crestview Wholesale that the defendant had in his possession. Mr. Long was also able to provide me information that lead to the recovery of 2 more Case knives that had been given to him by the defendant.

On November 26, 2017 Crestview Police Department notified this Deputy that CPD Officer David L. Daniels was out with the Defendant at East 1st Ave. and Anderson St. Upon arriving at this location consent had been given to search the defendant's property. A search of the defendants backpack produced 15 knives that had been stolen with an approximate total value of \$1,050.00. Also during conversation the defendant placed himself in the area of the burglary and in a Dodge pick-up that had been observed on video surveillance in the area during the burglary. The defendant was also wearing 'Ewing" shoes that matched the shoe impressions collected at the scene. The defendant was placed under arrest and transported to the Brackin Sub-Station.

The defendant was advised of his Miranda Warning and waived his rights. During an interviewthe defendant confessed to entering into the property by way of cutting a chain link fence. He then entered into building where he reports that he stayed for approximately 4 hours during the morning of November 23, 2017 where he deprived the owner of property arming himself with several knives and axes. The defendant stated that he went back during the morning hours of November 24, 2017 and stayed for approximately 2 hours depriving the owner of property and arming himself with knives. The defendant stated that he stole more than \$20,000 in property.

The defendant then admitted that he had hid several stolen knives in the yard of 404 E. 1 st Crestview, FL. The defendant was escorted to the location where he showed this deputy the hiding location. The knives were recovered and returned to William Rogers, the owner of Crestview Wholesale. The total amount of knives collected was 37 with an approximate value of \$2,590.00.

The defendant also admitted that other items were located at the residence of Vance Mitchell of 1713 Maple Ave. Niceville, FL. Contact was made with Mr. Mitchell, who provided a written statement that the defendant had borrowed his Dodge Ram truck 2 nights in a row and returned with a whole bunch of construction equipment. 28 items, 4 axes, and 15 knives identified as stolen were recovered at Mr. Mitchell's residence with a total approximate value of \$9,231.

The defendant made several phone calls to people that he had given stolen property to. These people were unaware the items they received were stolen. As of this report 2 people have arrived at the Brackin Sub-Station and returned 4 items and 16 knives identified as stolen with an approximate value of \$2,235.

The defendant also reported that he gave an unknown amount of items away and can't completely recall what items or who he gave them to. The defendant again reiterated that he stole more then \$20,000 dollars worth of property, adding that he did the math and research on what he stole.

Based on the above stated facts I have reason to believe the defendant Roberto Luis Solis II, committed the crime of Armed Burglary in direct violation of Florida State Statute 810.02(2b) (2 Counts), Grand Theft over \$20,000 in direct violation of Florida State Statute 812.014.2b. (1 Count), and Dealing in Stolen Property in direct violation of Florida State Statute 812.019(1) (3 Count).
