[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On November 29, 2017 while investigating a complaint of child neglect it was discovered the defendant, Danielle Rae Blankenship pulled a knife on her mother, the victim, Deanna Tate.

A sworn written statement provided by the victim states that on or about November 6, 2017 she got into a physical altercation. During the altercation the defendant pulled a razor knife and ran towards her calling her derogatory names. The defendant was intercepted by a witness as she aggressed on her mother, the victim. The victim and ██████████ then locked themselves in a bedroom.

While investigating the child neglect, DCF Investigator Lisa Vargo was asking the defendant questions. The defendant admitted to a physical altercation. The defendant denied being the aggressor but did state both her and the victim pulled a knife.

On November 29, 2017 I received copies of text messages between the defendant and victim. During a text message from the defendant to the victim, she states "That's why I ran outside and came back with my knife."

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On November 29, 2017 it was discovered that the defendant, Danielle Rae Blankenship had failed to seek medical attention for ██████████ for a head injury that he sustained on or around November 6, 2017. This head injury presented itself as an approximately 1.5 inch indentation in the back left head area.

The defendant was told by multiple family members to seek medical attention for the child and has failed to do so. The defendant on November 29, 2017 sought medical treatment after Law Enforcement began this investigation. During medical treatment the defendant failed to inform medical staff that the child had suffered trauma to his head.

Post Miranda the defendant admitted the child suffered trauma to the head, failed to seek proper medical services that a prudent person would consider essential for the well-being of a child with head injuries.

Based on the facts of this case, I have reason to believe the defendant, Danielle Rae Blankenship, committed the crime of Child Neglect. This is in direct violation of Florida State Statue 827.03(2d) This incident occurred in Okaloosa County, Florida, where I am a Sworn Law Enforcement Officer.
