[REDACTED] advised the Okaloosa County Sheriff's Office she believed a juvenile who is now an adult identified as [REDACTED] was being sex trafficked by a male who went by the name of "Ant" and that [REDACTED] was recruiting other juvenile females to participate in prostitution on behalf of "Ant." [REDACTED] also provided information that she found a female identified

[REDACTED] stated that two males who went by the names of "Ant" and "Day Day" were prostituting out a female who at the time was a juvenile identified as [REDACTED] was being sex trafficked with the help of [REDACTED] [REDACTED] stated both "Ant" and "Day Day" were also having sex with [REDACTED] who at the time of the report was a juvenile.

On May 6, 2016, your Affiant interviewed [REDACTED]. During the interview [REDACTED] stated the following:

[REDACTED] stated she was sex trafficked by Anthony Miles (AKA "Ant" DOB 2/8/1992) and De'Jion Kimbrough (AKA "Day Day"). [REDACTED] Stated Miles and Kimbrough sex trafficked her and other females in Okaloosa County, Orlando, Lakeland and Tallahassee. [REDACTED] stated Miles and Kimbrough would take all or a portion of the money earned for the sexual acts. [REDACTED] stated one of the other females sex trafficked was a [REDACTED] stated Miles and Kimbrough would use force in the form of battery and imprisonment to make the victims comply and that Miles and Kimbrough would also use coercion in the form of narcotics to make them comply. [REDACTED] recounted an instance when Kimbrough accused [REDACTED] and [REDACTED] of stealing money and battered both females while they were in Orlando. [REDACTED] also recounted a time when she was coerced to have sex with Miles and Kimbrough for narcotics and to allow her time off from prostituting. [REDACTED] stated there was evidence of the battery and trafficking on her Snapchat account "[REDACTED]" Corroborating evidence was discovered on [REDACTED] Snapchat account of the battery after a search warrant was executed on her Snapchat account.

On August 10, 2017, I interviewed [REDACTED]. During the interview [REDACTED] stated the following:

[REDACTED] stated she was sex trafficked by Anthony Miles and De'Jion Kimbrough. [REDACTED] corroborated [REDACTED] statements on the battery which occurred in Orlando and that Miles would take all or a portion of the money earned for sexual acts. [REDACTED] stated she was coerced into to continuing to prostitute through narcotics and threats. [REDACTED] recounted an incident when Miles took her phone and Florida Driver's License from her and would not return them because [REDACTED] had defied his instructions. [REDACTED] also knew Miles and Kimbrough had had sex with [REDACTED] was seventeen (17) years old at the time of the occurrence. [REDACTED] stated there was evidence on her Facebook page which would corroborate her statements. Search Warrant s were issued and searched to Facebook and Snapchat in reference to the case and corroborating evidence was discovered on [REDACTED] Facebook page of Miles involvement in the sex trafficking and the battery which occurred.

On September 18, 2017, a search warrant was executed at Keep Safe Storage located at 101 Hospital Drive, Crestview, Florida unit E22, which is rented by Anthony Miles. During the search of unit E22 [REDACTED] Florida Driver's License was discovered which corroborated her allegations that her driver's license was taken by Miles.

On September 9, 2017, De'Jion Kimbrough was arrested in Okaloosa County on warrants out of DeKalb County, Georgia.

On September 9, 2017, I interviewed Kimbrough at the Okaloosa County Sheriff's Office investigations building. The entire interview was recorded and stored on evidence.com the following is a summary of the interview.

Post Miranda Kimbrough did admit to knowing [REDACTED] Kimbrough met them at the Motel 6 in Destin Florida some time November of 2016.

Kimbrough admitted he had the phone number of 850-[REDACTED] for three years. (This is the same number which was used to place 63 Backpage.com advertisements.)

Kimbrough stated [REDACTED] asked him to help them get customers.

Kimbrough stated he asked Anthony Miles for help with placing the advertisements on Backpage.com and that Miles did help with placing the Backpage.com advertisements because he understood how to use Bitcoins.


