[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Your affiant has reason to believe and does believe the 15 Year Old Defendant, Robert Cameron Blalock, did commit the criminal offenses of Intimidation Write, Send, Threat to Kill or Injure F.S.S 836.10 and Possession of Firearm Under the Age of 18 F.S.S 790.22(3).

On January 11, 2018 at approximately 1631 hours reporting person, Jonathan Olson, notified me of a threat he observed on Snapchat from user (birdshot19) which returned to the defendant. Olson advised the first post posted from the defendant showed a revolver .22 caliber pistol which was immediately followed by a second post that read, "Cameron about to go on a rampage." Olson is a school official at Ruckel Middle School where the defendant attends school. Olson expressed immediate concern and fear for the safety of the students and staff based on the defendant's posts on a public social media form.

I immediately responded to the defendant's residence at the second of the latest post of the defendant advised the gun in the post was an air soft pistol and did not know where it was located. After further

interview with the defendant he advised he had the loaded revolver in his dresser drawer and a loaded .22 caliber rifle in his closet. The defendant advised he did post the loaded revolver on his Snapchat account and immediately following the picture of the gun posted the afore mentioned threat. The defendant advised he made the posts in hopes that a specific student would see them and be scared due to the fact the student made him mad at school on this date.

I made contact with the defendant's mother, April Blalock, who stated she did not have knowledge of the defendant being in the possession of the .22 caliber Revolver.

These offenses occurred in Okaloosa County where I am a sworn law enforcement officer.
