

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 11 January 2018, The Okaloosa County Sheriff's office responded to  Crestview, Florida in reference to a battery complaint.

Upon arrival, victim  reported she was a victim of a Domestic battery , false imprisonment and sexual battery.

Victim [REDACTED] reported from 9 January to 11 January 2018 she was staying with [REDACTED] defendant David Hamilton Brown at his residence identified as 4507 Furling Lane, Apartment 305, Destin, Florida.

Victim [REDACTED] reported she and defendant Brown have a relationship spanning [REDACTED] and have had a sexual relationship during this time frame(intimate relationship).

Victim [REDACTED] reported her and defendant Brown recently returned from a [REDACTED] shared a cabin.

At approximately 0100 hours on 11 January 2018, victim [REDACTED] and defendant Brown went to bed together and defendant Brown became upset over victim [REDACTED] placing her hand on his stomach affectionately.

Defendant Brown started calling victim [REDACTED] a barrage of names such as "Cunt, slut, whore, piece of shit and worthless" among other names.

Victim [REDACTED] became upset and started to cry and defendant Brown made the comments such as "don't give me those tears; I will make you cry. I want you dead."

[REDACTED] reported defendant Brown attacked her by twisted and biting her arm, bit her on the right cheek, bit her on the right breast and shoved her off the bed with his foot.

Defendant Brown held his hand over her mouth and scratched victim [REDACTED] left side of nose and placed a pillow over her face and tried to suffocate her.

Defendant Brown would push her head left and right with his hand and push her against the wall and advised victim [REDACTED] he was trying to break her neck.

Defendant Brown punched her in the stomach, back and kicked her in the thighs when he was laying next to her in the bed.

Defendant Brown grabbed victim [REDACTED] by the ankles and pulled her off the bed.

Victim [REDACTED] reported she was airborne when pulled off the bed and she struck her head.

Victim [REDACTED] attempted to leave the room when she believed Brown was sleeping and defendant Brown stood between her and the door.

Defendant Brown told her "your not leaving" and "your not going anywhere" "You're a piece of shit and I want you to die."

Victim [REDACTED] reported she requested defendant Brown to please let her leave and defendant Brown ordered her to get back into the bed.

Defendant Brown climbed on top of victim [REDACTED] and had sex with her against her wishes and the sex was uninvited and unwanted.

Victim [REDACTED] reported she did not resist defendant Brown during the sex or tell him no as she was fearful as defendant Brown had already battered her.

Victim [REDACTED] reported she was scared for her life and believed defendant Brown was trying to kill her during the attack.

Victim [REDACTED] was able to escape defendant Brown's residence at approximately 9am and she called into work ,returned home and contacted OCSO to report the incident.

I confirmed defendant Brown's address from a previous battery complaint in November 2017 at defendant Brown's

residence; 4507 Furling Lane, Apartment 305, Destin, Florida.

I went to defendant Brown's address, knocked on the door three times and rang the doorbell to interview defendant Brown.

The dog inside the residence started barking loudly, but no one answered the door.

I called defendant Brown's phone and left a voicemail identifying myself and a request to speak to him about the pending investigation.

Defendant Brown has failed to contact me or return my phone call as of 12pm on 12 January 2018 to provide a statement.

I saw victim [redacted] right wrist was swollen and red and [redacted] was unable to write out a sworn statement due to the injury to her right wrist.

I saw two red marks above her wrist, a mark on the soft tissue between her thumb and fore finger, a scratch on her left nose, a red mark on her right cheek, a raised area above her left temple which appears to be a bruise and redness on the left side of her neck.

Deputy Dowdy reported seeing the victim had a bite mark above her right breast.

I reviewed the documentation from the North Okaloosa Medical Center and injuries consistent with the victims report of injuries.

Victim [redacted] reported the North Okaloosa Medical Center advised her she has whiplash and her right wrist is sprained.

Drawing upon my 19 years of experience as a law enforcement officer and 5 years as a Crime Scene Investigator investigating in excess of 115 battery complaints, I believe the injuries(evidence) is consistent with the allegations being made by the victim.

Based upon the above stated information, I have reason to believe and do believe defendant David Hamilton Brown committed the unlawful offense of Battery(DOMV), false imprisonment and Sexual Battery(DOMV) in violation of F.S.S. 784.03(1)(a)(2), 794.011(4)(b) and 787.02(1)(a).
