[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On January 17, 2018 the Defendant, April Ann Griffin, committed the offense of Grand Theft in violation of F.S.S. 812.014.2c.

On the aforementioned date, Griffin came into the WalMart located at 748 N. Beal Pkwy, Fort Walton Beach Florida, 32547. While inside WalMart, Griffin went to the victim's grocery cart and took the victim's purse while her back was turned. Griffin then goes into the women's bathroom with the victim's purse. After approximately one minute, Griffin comes out of the restroom without the purse and leaves WalMart. The victim recovers the purse and discovers an envelope which contained \$1,011.00 had been taken.

On the camera footage captured by WalMart I observed Griffin take the purse from victim's grocery cart. I then observed Griffin take the purse into the women's restroom and then come out of the restroom without it approximately one minute later. I then observed Griffin leave WalMart and get into a white Chevy 4D vehicle. It should be noted that the surveillance footage clearly shows Griffin committing the offense and using the clear footage I was able

to identify her from her picture on the MasterName Index used by the Okaloosa County Sheriff's Office.

On January 18, 2018 contact was made with Griffin at the Texaco located at 306 Racetrack Rd NW, Fort Walton Beach, FL 32547 where Griffin admitted to being at the incident location during the time of incident. Griffin denied any involvement in the incident.

Based upon my investigation I have probable cause to believe and do believe that the Defendant, April Ann Griffin, committed the offense of Grand Theft in violation of F.S.S. 812.014.2c. This incident occurred on Okaloosa County.
