[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On January 7, 2018, I responded to a suspicious activity just occurred at 3925 Poverty Creek Rd, Crestview, FL. A neighbor observed the co-defendants remove boxes from the front porch and get into a small silver car with black rims.

While responding to the aforementioned address, I observed a Silver Toyota Prius with black rims, traveling west on Airport Rd. I turned around and attempted to catch up to the vehicle. While trying to locate the vehicle in Brooks Estates subdivision, an Amazon box was observed in the middle of Barton Rd. As we circulated the subdivision looking for the vehicle, it was observed on Crown Creeks Cir. A traffic stop was initiated on that vehicle, bearing FL registration #HC3B34, in front of 3012 Crown Creeks Cir.

In a sworn affidavit of complaint, the victim provided the following list of items that where in the boxes: The same items were located in the vehicle during the traffic stop. The victim did verbally state that he did not give anyone permission to take the boxes from his home.

1. Proxy lighting 48" water proof string lights. \$48.95
2. Vegetable Spiralzier 5 blades. \$19.97

All of the above listed items, with the exception of the Otter Box, were located in the rear seat area of the vehicle where the co-defendants were sitting. Along with the property, were labels that had been removed from the stolen boxes with the victims information on them.

During interview with the defendant, he stated he and Brent Sienko stayed in the vehicle while the burglary and theft occurred at 3925 Poverty Creek Rd.

Witnesses along Border Creek Rd observed boxes being thrown from the suspect vehicle as it passed. Video surveillance from an address on E. Brooke Dr. shows a small silver Toyota Prius drive by with an open rear passenger door. The passenger is then observed discarding a box onto the street.

Based on the above investigation, I have probable cause to believe that the Defendant Zane Aaron Hall did Violate FSS 810.02(3b) Burglary to an Unoccupied Dwelling, and FSS 812.014(2e) Petit Theft. This offense did occur in Okaloosa County Florida where I am a Full-time Law Enforcement Officer.

During interviews with co-defendants Brent Sienko (Driver) and Zane Hall (Front Passenger), both stated they stayed in the vehicle while at 3925 Poverty Creek Rd. The defendant on several of occasions, wanted to take responsibility for the entire incident and admitted to discarding the boxes while law enforcement was attempting to catch up to them.

Witnesses along Border Creek Rd observed boxes being thrown from the suspect vehicle as it passed from the rear driver side. Video surveillance from an address on E. Brooke Dr. shows a small sliver Toyota Prius drive by with an open rear passenger door. The passenger is then observed discarding a box onto the street.

Based on the above investigation, I have probable cause to believe that the Defendant Blake Allan Sienko did Violate FSS 810.02(3b) Burglary to an Unoccupied Dwelling, FSS 812.014(2e) Petit Theft, and FSS 913.13(1a) Tamper with or Destruction of Evidence. This offense did occur in Okaloosa County Florida where I am a Full-time Law Enforcement Officer.

A traffic stop was initiated on that vehicle, bearing FL registration #HC3B34 in front of 3012 Crown Creeks Cir.

All of the above listed items, with the exception of the Otter Box, were located in the rear seat area of the vehicle where two of the co-defendants was sitting. Along with the property were labels that had been removed from the stolen boxes with the victims information on them.

During interviews with the defendant (Driver) and co-defendant Zane Hall (Front Passenger), both stated they stayed in the vehicle while at 3925 Poverty Creek Rd. The defendant did attempt to elude law enforcement upon sight so that co-defendants Blake Sienko and Victoria Clark could discard the evidence packaging/boxes.

Witnesses along Border Creek Rd observed boxes being thrown from the suspect vehicle as it passed from the rear driver side. Video surveillance from an address on E. Brooke Dr. shows a small silver Toyota Prius drive by with an open rear passenger door. The passenger is then observed discarding a box onto the street.

Based on the above investigation, I have probable cause to believe that the Defendant Brent Joseph Sienko did Violate FSS 810.02(3b) Burglary to an Unoccupied Dwelling, FSS 812.014(2e) Petit Theft and FSS 918.13(1a) Tamper with or Destruction of Evidence. This offense did occur in Okaloosa County Florida where I am a Full-time Law Enforcement Officer.
