[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On December 5, 2017 the Defendant, Ryan Michael Johnson, did commit the offense of Lewd and Lascivious Exhibition in the presence of a minor less than 16 years of age. The Victim [REDACTED]/2005, by sworn Affidavit, stated that on December 5, 2017 she observed the Defendant exposing his penis and masturbating in the edge of the woods across from her school bus stop, located at Aplin Road @ Patriot Lane, Crestview Florida. The Victim, [REDACTED] identified the Defendant with certainty as Ryan Michael Johnson. She stated it was they same man she identified before as having masturbated in her presence at the bus stop in a previous case (OCSO17OFF12064). Also present was Victim, [REDACTED]2006. Victim [REDACTED] by sworn Affidavit, stated he observed an adult male expose his penis and masturbate in their presence at the edge of the woods across from their school bus stop. According to, Victim, [REDACTED] "the man was looking at us and rubbing his penis". Victim [REDACTED] was presented with a photographic line-up consisting of the Defendant and five other individuals of similar appearance. The Victim, [REDACTED] selected Photo #2 and #3 "as "looking most similar" to the Suspect. Photo #2 in the prepared line-up is Defendant, Ryan Michael Johnson. Upon my last attempt to question the Defendant, he declined making any statement to law enforcement.

This offense occurred in Okaloosa County, Florida in violation of Florida Statute 800.04(7)(a)(1)(2).
