[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 15, 2018, at approximately 1309 hours, the Defendant, Charles Javonte Burke Jr. carried a concealed weapon about his person in your Affiant's presence who is a sworn law enforcement officer in the state of Florida. Based on the fear of the complainant and the defendant's disregard of his actions, he corrupted the morals of the public.

On February 15, 2018, at approximately 1307 hours, the Okaloosa County Sheriff's Office received a call from a concerned parent of a student at Pryor Middle School; the witness/complainant observed a black male walking south on Denton Boulevard armed with a silver and black pistol. The caller and witness to this occurrence, described the male to dispatch as units responded.

A male matching the detailed description provided was observed walking south on Denton Boulevard; contact was made with this male in the area of 695 Denton Boulevard, Fort Walton Beach, Florida, 32548. Upon contact, and commands to place his hands in the air, the male exclaimed "it's a BB gun." The male was detained and found to be

possessing a silver, and black device which resembled a gun tucked within his waistband on his left side covered by his shirt. Upon further investigation, the device was identified as a BB/Pellet gun.

The witness responded to this location and provided a sworn statement as to what occurred. In this statement, he advised the male held a "silver and black pistol in his left hand." While he was walking, he was observed the Defendant, point the gun towards Pryor's property where workers were working outside in a field and towards a tree. The witness stated he was in fear for his safety along with the safety of the children and workers on the schools' properties.

Post Miranda, the Defendant stated he was "shooting squirrels."

Based on Okaloosa School Policies, the recent school shootings in South Florida, and the fact the witness was in fear for his safety and the safety of others, the defendant's actions created a breach of peace on Pryor's school property causing the normal school day to be disrupted and be placed on LOCKDOWN, affecting the peace of the students and faculty.

Based on these incidents I have reason to believe and do believe the Defendant, Charles Javonte Burke Jr. committed the offenses of F.S.S 790.01.1 Carrying a Concealed Weapon or Device and F.S.S. 877.03 Breach of Peace; Disorderly Conduct.

These offenses occurred in Okaloosa County.
