[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 21, 2018, deputies arrived at 403 Azalea Drive, Destin, Florida, in order to serve an arrest warrant on the defendant Jessica Rae Figures. The codefendant, Leroy Figures, notified deputies that the defendant was in the back bedroom. Several attempts to call the defendant out were made without the defendant coming out or making her presence known. Deputies entered the home and continued to call the defendant out. The defendant was eventually located hiding under a pile of blankets in the back bedroom.

On February 21, 2018, your Affiant obtained a lawful search warrant for the above residence, 403 Azalea Drive. It was executed by members of the Okaloosa County Sheriff's Office.

Upon executing the search warrant, deputies recovered a .45 caliber Kimber semi-automatic handgun, crack cocaine, heroin, and drug paraphernalia. The packaging for the crack cocaine and the heroin was indicative of distribution. Furthermore, deputies located an "owe sheet" indicating debts owed and debts paid inside a box where some of the heroin was located.

Post Miranda warning, the defendant stated she and the codefendant both sold heroin and crack cocaine from their residence. The codefendant also stated she observed the handgun under the bed within the past few months, so she moved it into the codefendant's nightstand. The defendant also admitted that she heard deputies calling her out of the home, but she elected to hide because she was scared and she knew she had a warrant.

A check of the defendant's criminal history showed that she was a convicted felon in the state of Florida. The defendant was also found to be on Felony Probation from December 26, 2017 until December 20, 2022.

Your Affiant has reason to believe and does believe the defendant, Jessica Rae Hinds, did unlawfully violate F.S.S. 893.13(1)(a)1 - Possession of a Controlled Substance with Intent to Distribute; F.S.S. 790.23(1)(a) - Possession of a Firearm by a Convicted Felon; F.S.S. 893.147(1) - Possession of Drug Paraphernalia; F.S.S. 843.02 - Resist Officer Without Violence; and F.S.S. 948.06(a) - Felony Violation of Probation. These offenses occurred in Okaloosa County, Florida, where your Affiant is a certified law enforcement officer.
