

On February 19, 2018, members of the Okaloosa County Sheriff's Office responded to a burglary complaint at 7866 Steel Mill Creek Road, Laurel Hill, Florida.

The complainant/VICTIM, Jacob LOCKE, advised responding deputies that his nine year old son was home alone when a white male knocked on the door of the residence. The male, who was later identified as the DEFENDANT, William FONTENOT, told the juvenile that he was at the residence to retrieve something on behalf of LOCKE; however, the male never stated the VICTIM's name.

The DEFENDANT entered the residence and went into the master bedroom. Once inside of the master bedroom, the DEFENDANT removed approximately two-hundred dollars (\$200.00) in miscellaneous currency from a dresser drawer and approximately four-hundred dollars (\$400.00) in loose change from the master bedroom closet. The DEFENDANT then departed the residence in newer Nissan Titan, bearing a partial Florida registration of "GW".

Video surveillance footage from the exterior of the residence was consistent with the male's arrival, departure, and vehicle description.

On February 21, 2018, Lieutenant Matthew ABBOTT received a telephone call from Sergeant Jeff DANIEL of the Covington County Sheriff's Office. Sergeant DANIEL's advised, the Covington County Sheriff's Office stopped a black 2017 Nissan Titan, bearing Florida registration #GWJW12 (Hertz rental vehicle). The vehicle was occupied by the DEFENDANT and matched the suspect's vehicle during this incident.

On February 21, 2018, Crime Analyst Katie PARKER created a photographic array that included the DEFENDANT.

On February 21, 2018, I met the VICTIM and his juvenile son at the Okaloosa County Sheriff's Office. The photographic array, containing the DEFENDANT's photograph, was provided to the juvenile in the presence of LOCKE. The juvenile immediately identified the DEFENDANT as the individual that entered the residence and removed the currency. The juvenile indicated he spoke to the DEFENDANT, therefore, he remembered the DEFENDANT's face very well.

Based on the information and evidence presented in this investigation, it is obvious that the DEFENDANT entered the above mentioned residence, under false pretenses, with a juvenile present inside, to commit a theft therein.

There is probable cause to believe, and your AFFIANT does believe, William FONTENOT knowingly violated Florida State Statues 810.02.3; Burglary of an unoccupied dwelling and 812.014.2c1; Grand theft. This incident did occur within Okaloosa County, Florida, where your AFFIANT is a sworn Law Enforcement Officer.

On 2/15/2018, I responded to a burglary which already occurred at 6070 Old Bethel Road, Crestview, Florida. The defendant, William Richard Fontenot, who was identified in video footage, committed the act of Burglary to a structure and Grand theft over \$300.00. Fontenot was identified by the victim, who has had prior encounters through personal history.

On 2/10/2018, at approximately 1800 hours, the defendant entered the back yard through a locked gate at the aforementioned location. After entering the back yard, the defendant removed tools from the shed and placed them into a five gallon bucket. The items taken from the shed are as follows: (1) Porter Cable Skill saw and (1) Porter Cable Reciprocating Saw, valued at \$650.00.

Based on my investigation which consisted of my personal observation and physical evidence, I have reason to believe and do believe the defendant, William Richard Fontenot, violated the provisions of F.S.S. 810.02.4a Burglary Of A Structure and F.S.S 812.014.2c1 Grand Theft More Than \$300 Less Than \$5000. This offense occurred in Okaloosa County, Florida, where I am a sworn Law Enforcement Officer.
