[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

I have just and reasonable grounds to believe, and do believe the above named defendant, Thomas Harold Davis Sr, did commit the offense of F.S.S. 784.045(1A2): Aggravated Battery - Cause Great Bodily Harm With A Deadly Weapon and F.S.S 782.051.1: Attempted Felony Murder, on February 5, 2018. This offense occurred at 5263 Barnes Road, Crestview, Okaloosa County, Florida. The defendant is the biological father of the victim, Thomas herald Davis Jr. Subsequently Thomas Jr is married to victim, Sharon Rachel Moore. The evidence to substantiate these charges is as follows:

Victim Sharon Rachel Moore, who is the daughter in-law to the suspect, provided a written statement indicating the suspect shot a long gun in her direction. The suspect pointed the long gun at Moore and fired the round into the dirt causing a ricochet to hit her in the neck.

Victim Thomas Harold Davis Jr, who is the son of the suspect, provided a sworn verbal statement indicating the suspect did state "I'm gonna fucking kill you boy" and then raised the rifle aiming it at Thomas Jr. The suspect then fired one round at Thomas Jr, but missed his target. Thomas Jr began to walk away from the suspect very fast with the actions of being in fear of his life. While walking away the suspect fired another round missing Thomas Jr.

I observed the Moore's injuries as being a swollen lump, with the consistency of being an entry wound.

The defendant was read his Miranda Rights to which he acknowledged understanding and invoked his right to remain silent.

This incident occurred as a follow up from the incident earlier in the morning. The victim's went back to the location after several hours in an attempt to check on the mother. The suspect took offense to these actions and further stated he was going to kill Thomas Jr and subsequently fired a live round at Sharon Moore.

This incident occurred in Okaloosa County, Florida where this Affiant is a sworn law enforcement officer.

I have just and reasonable grounds to believe, and do believe the above named defendant, Thomas Harold Davis Sr, did commit the offense of F.S.S. 784.045(1A1): Aggravated Battery - Cause Great Bodily Harm, on February 5, 2018. This offense occurred at 5263 Barnes Road, Crestview, Okaloosa County, Florida. The evidence to substantiate this charge is as follows:

Principal

Victim Linda Carol Davis, who is the wife of the defendant, provided a sworn verbal statement indicating the defendant did maliciously beat her with wooden leg from a table across her back. When the defendant stopped, he started violently punching her in the face and head a reported 10 to 15 times. The argument stemmed over the defendant not having his medications.

I observed the victim's injuries as being a swollen shut, black and blue right eye. She had multiple contusions starting with the one just above her right eye on her forehead, and several from the crown of her head leading downward towards the top of her right ear. The contusions on the top of her head were severe enough to form what felt like a berm. The contusions extended to the rear of her head as well. The victim had an approximately 3-inch laceration on the inside of her right forearm.

The defendant was read his Miranda Rights to which he acknowledged understanding and invoked his right to remain silent.

The defendant's and victim's 40 year old son, Thomas Harold Davis Jr., and his wife, Sharon Rachel Davis, responded to a text from the victim for assistance. When they both arrived at the residence, Thomas Jr. engaged in a verbal argument in which the defendant and Thomas Jr were yelling and grabbing each other over the defendant's actions against the victim. Thomas Jr. and Sharon Rachel Davis left the residence after this.
