[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 19, 2018, at approximately 1823 hours, I received a phone call regarding a Snapchat post.

The Snapchat post consisted of a picture of an M-4 assault rifle. The picture did not have anybody in it but did have the words "I would kill people, I wanna shoot a school and round 2 of Florida".

The reporting person, [REDACTED] stated on February 19, 2018, at approximately 1706 hours, she received a Snapchat post from user name "verifydfinesser" which is the Snapchat user name for [REDACTED] defendant, Roman Jackson. [REDACTED] stated she did not take the post serious and thought he was just being "stupid". According to [REDACTED] she immediately sent a Snapchat post back to the defendant advising he could get in trouble for sending that post. The defendant told [REDACTED] he was "just kidding".

The defendant, in a verbal statement, admitted to posting the above mentioned post, via Snapchat, but said he was just trying to play a "joke" and did not mean anything by it. I asked the defendant how many people he sent the post to and he advised the post was sent as a group post therefore, he is unsure how many people received the message. The defendant explained he got the picture of the M-4 assault rifle by searching the image on "Google". After locating the picture, the defendant then typed the words "I would kill people, I wanna shoot a school, and round 2 of Florida" onto the image of the rifle. The defendant further stated he did not have anyone in mind when he posted the Snapchat post nor did he have a specific school in mind and was just playing a stupid joke.

The defendant advised he used his pink and white Apple Iphone SE to type and send the Snapchat post in

question. The defendant confirmed his phone number is 850-974-9433 and his Snap Chat user name is "verifydfinesser".

Based on the above investigation, verbal statements, and evidence of the Snap Chat Post, I have reason to believe and do believe the defendant, Roman Tyrese Jackson did commit the offense of Written threats to kill or do bodily injury in violation of F.S.S. 836.10. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.
