

parked at a gas pump at Tom Thumb, 1992 West James Lee Boulevard.

Upon making contact with the occupants, JARED C. SMITH and Amanda Hatton, who were seated in the front seats. Sergeant Rader found they were unresponsive. He also saw crystalline substance, consistent with methamphetamine, and uncapped needles on the center console in plain view easily visible from the exterior of the vehicle.

After waking the occupants, they were detained. A probable cause search of the vehicle revealed multiple hypodermic syringes, one of which contained liquid, and a plastic container with green powder. A sample of the crystalline substance was field tested and provided a positive result for the presence of methamphetamine. A sample of the green powder was field tested and provided a positive result for the presence of Oxycodone.

 child was sleeping in the back seat of the vehicle. My investigation revealed they arrived at the gas station since approximately 2045 hours. The child was unsupervised for approximately two hours, with methamphetamine and Oxycodone within easy reach of the child. There were also uncapped and drug filled hypodermic syringes within reach of the child.

Based on the aforementioned facts and investigation, I find probable cause to believe JARED C. SMITH violated FSS 893.13.6a Possession of a Controlled Substance without a Prescription, to wit methamphetamine, FSS 893.13.6a Possession of a Controlled Substance without a Prescription, to wit Oxycodone, 893.147.1 Possession of Drug Paraphernalia, and FSS 827.03.2d Child Neglect without Great Bodily Harm. These offenses occurred in Okaloosa County, where I am a sworn law enforcement officer.
