[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On March 1, 2018 I responded to 5784 Highway 4 Baker, Florida in reference to an aggravated battery that had just occurred. Upon arrival, it was determined the victim Jake Bell and the defendant Samuel Brunson Jr. reside together as room mates at the above address.

An investigation into the incident revealed Brunson and Bell were involved in a verbal argument regarding Bell using narcotics inside the residence. During the argument, Bell pushed Brunson three separate times and laughed at him while located in the living room of the home. Brunson then departed the room and armed himself with a metal hatchet which was located beside the front door. Brunson returned to the room wielding the hatchet as they again began to argue. While standing in the living room, Bell pushed Brunson and began walking away toward the couch. Bell then stopped and looked at Brunson. Brunson then approached Bell and struck him on the outside of the upper left arm with the hatchet, against his will. As a result of being struck by the hatchet, Bell suffered a laceration to the upper left arm which required five staples to close once at the hospital.

Based on the above information I have reason to believe and do believe Samuel Brunson Jr. violated F.S.S. 784.045(1a2) Aggravated Battery. This offense did occur in Okaloosa County Florida where the affiant is a sworn law enforcement officer.
