



[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 03/02/18 members of the Okaloosa County Sheriff's Office Street Crimes Unit were conducting patrols in the area of Fort Walton Beach, Florida.

I initiated a traffic stop on a 2009 Honda motorcycle bearing Florida registration MDUS25, because the registration was not legible. The registration was not legible because the motorcycle had no tag lights, the characters on the registration were worn off and the registration was crumpled.

I made contact with the motorcyclist/defendant, Matthew Christopher Herring, and explained the reason for the stop. I asked the defendant if he had any weapons on his person, and he stated no. I asked him if he had any knives on his person, and he stated yes. D/S Paxton Shelton informed the defendant, he was going to conduct a pat down of his person, for weapons. While seated on the motorcycle, the defendant stated no, and pressed the ignition switch on the motorcycle. The engine started. D/S Paxton Shelton was able to pull the defendant off the motorcycle, before he could flee. Once D/S Paxton Shelton pulled the defendant off the motorcycle, he gave the defendant commands to get on the ground. The defendant refused to get on the ground. I informed D/S Paxton Shelton I was going to tase the defendant. The defendant overheard me, and stated don't tase me; however, he did not get on the ground. D/S Paxton Shelton conducted a leg sweep on the defendant, which caused him to fall to the ground. The defendant was placed in handcuffs, and searched incident to arrest.

The defendant was wearing a motorcycle jacket. A .22 caliber Derringer was removed from his left jacket pocket and a .38 special revolver was removed from his right jacket pocket. The defendant was wearing a back pack. Inside the backpack was a pouch that contained approximately 1 gram of Heroin and 1 gram of Methamphetamine (both field tested positive). There was also a digital scale, several unused jewelers baggies, and an unopened packet said to contain a Suboxone, in the same compartment as the Heroin and Methamphetamine. Based on my experience, I believe the combination of drugs, a digital scale and unused baggies is indicative of intent to distribute

Post-Miranda, the Defendant stated he did not tell deputies about the firearms, because he knew he was a convicted felon. He admitted to being a drug user, but did not know what type of drugs were in the backpack.

A criminal history check revealed the defendant was a convicted felon and the respondent of a permanent domestic violence injunction.

The defendant did violate F.S.S. 790.23(1a) possession of firearm by convicted felon; the defendant did violate F.S.S. 790.01(2) carrying a concealed firearm; the defendant did violate F.S.S. 790.233(1) possession of a firearm while having a final injunction; the defendant did violate F.S.S. 790.07(2) possession of firearm while in the commission of a felony; the defendant did violate F.S.S. 893.13(1a1) possession of heroin with the intent to distribute; the defendant did violate F.S.S. 893.13(1a1) possession of methamphetamine with the intent to distribute; the defendant did violate F.S.S. 893.13(6a) possession of a controlled substance without a prescription to wit: Suboxone; the defendant did violate F.S.S. 843.02 resisting an officer without violence.

The violations did occur in Okaloosa County Florida where I am a sworn law enforcement officer.
