[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 20, 2018 Deputies responded to the area of Log Lake Rd. and Sky Lane in reference to a disturbance. Upon arrival to the area, it was determined the victim and defendant had relocated to The Rivers Edge Campground located at 4001 Log Lake Rd. Holt, Florida. Deputies responded to that location where contact was made with the victim Steven Bashore and the defendant Megan Ostman. An investigation into this incident revealed Bashore and Ostman have resided together as a family unit since October 2014 and have a child in common.

On the above date, Ostman and Bashore were involved in a verbal argument while inside a vehicle whereas Bashore was the driver and Ostman was the passenger. During the argument, Ostman acquired a hammer from the floor of the vehicle and struck Bashore in the head and on the right forearm. As a result of being struck, Bashore suffered swelling and abrasions to the left rear of the head and swelling to the right forearm. During an interview with Ostman, she admitted to striking Bashore with the hammer. Evidence inside the vehicle and Bashore's injuries were consistent with statements provided.

Based on the above information the affiant has reason to believe and does believe the defendant Megan Ostman violated F.S.S. 784.045(1a1) Aggravated Battery. This offense did occur in Okaloosa County where the affiant is a sworn law enforcement officer.
