Based on the violation, your Affiant initiated a traffic stop on the Chevrolet, and the Chevrolet came to a complete stop near the intersection of Navy Street and Racetrack Road, Fort Walton Beach. Once the Chevrolet was stopped, your Affiant approached the Chevrolet and identified the driver as Eian WILSON (Defendant).

During a roadside investigation it was determined WILSON was fourteen (14) years of age and did not possess a valid driver's license. This was based on WILSON stating he was fourteen (14) years old and has never had a driver's license, and OCSO Dispatch confirmed the status via a NCIC query.

Your Affiant requested WILSON exit the Chevrolet, to which he complied. Your Affiant then asked WILSON if there were any illegal narcotics or weapons within the Chevrolet, to which he replied there was a firearm in the Chevrolet. During a search of the Chevrolet, Deputy Sheriff Wilhelm located the following:

- One (1) pink Taurus .380 handgun, serial number 91121C. The firearm was located tucked between the front passenger's seat and the center console. This area was readily accessible to WILSON during the traffic stop.

Post Miranda, WILSON stated he took the Chevrolet without Amber DURBIN's (Victim/Mother) permission. WILSON stated he also took the firearm from DURBIN's bedroom without her permission. When questioned why WILSON took the firearm, he replied he felt as if something bad was going to happen.

DURBIN filed an Affidavit of Complaint for the vehicle, but did not wish to pursue charges for the stolen firearm.

Based on the above, your Affiant has probable cause to believe Eian WILSON (Defendant) violated Florida State Statutes 790.01.2: Carrying Concealed Firearm; 812.014.2c6 Grand Theft of Motor Vehicle; and 322.03.1 No Driver's License - Never Issued.
