[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On March 26, 2018, at approximately 0133 hours, Chester Brady Walker, was in possession of a controlled substance without prescription. This incident occurred at Tom Thumb located at 1096 N. Beal Parkway, Fort Walton Beach, Florida.

I was pumping gas at the above listed gas station when I observed a blue 2015 Nissan SUV bearing FL/GEVQ26 at a gas pump across from me. Walker was in the drivers seat and had his head slumped over. I went to check on him and observed he was sleeping while the vehicle was running. I got Walker attention, woke up and rolled down the window. Walker was very difficult to understand, but when asked what was going on, he said, "bare naked" and the rest I couldn't make out.

While speaking with Walker K9 Esuda conducted a free air sniff of the vehicle. K9 Esuda showed a positive hit.

A black soft case was located in Walkers front left pocket. Inside it contained heroin, crack cocaine, methamphetamine, fentanyl, alprazolam and quetiapine fumarate. A needle was located in his right front pocket.

Inside the vehicle, under the passenger seat was located alprazolam and a digital scale.

Post Miranda, Walker originally denied ownership, even going as far as stating the pants weren't his. He later admitted he was delivering the narcotics to customers for his dealer as a runner. He stated the needle was even for customers who didn't have them and needed it for usage. He admitted to being in possession of heroin, quetiapine fumarate and the methamphetamine.

The heroin, crack cocaine, methamphetamine and fentanyl were field tested and provided presumptive positive results.

Based on my investigation which included interviews with the suspect and physical evidence, I have reason to believe and do believe, Chester Brady Walker violated F.S.S. 893.13(6)(A) Controlled Substance Without Prescription X4, F.S.S. 893.13(6)(A) Possession of Cocaine and F.S.S. 893.147(1) Possession of Drug Paraphernalia. This incident occurred in Okaloosa County where I am a sworn law enforcement officer.
