[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

The defendant was observed by this Deputy to be in possession of an alcoholic beverage, specifically Michelob Ultra Beer. The defendant was identified as being 20 years of age. This is a violation of F.S.S. 562.111(1), dealing with the Unlawful Possession of Alcoholic Beverages.

After a search incident to arrest of the defendant, a soft sunglass case was located in the defendants left front pocket. Inside the sunglass case was 19 individual baggies containing a white powder substance. While ascertaining the contents, the defendant fled on foot from this deputy. This deputy was in full uniform at the time next to my marked patrol vehicle, and performing his lawful duties when the defendant fled on foot. After a brief foot pursuit, the defendant was apprehended. This deputy never lost sight of the defendant. This is in violation of F.S.S. 843.02, resisting arrest without violence.

A field test of two of the baggies was positive to contain cocaine.

Due to the 19 individual baggies located on the defendant, which based on my training and experience, the small baggies are consistent with the sale and distribution of narcotics, the defendant is in violation of F.S.S. 893.13, possession of cocaine with intent to distribute.

This offenses did occur in Okaloosa County, where this deputy is a sworn law enforcement officer.
