enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since August 2016. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On March 4, 2018 a 2018 black in color Toyota Rav 4 bearing Florida tag ITUW47 was reported stolen from 2194 Sapphire Court, Fort Walton Beach Florida, Florida by Amanda GRANT (victim).

On March 5, 2018, Okaloosa County Sheriff's Deputies observed the defendant, Lakeith Jamar ARMSTRONG, in possession of the stolen vehicle located in the parking lot of the Tom Thumb located at 1096 Beal Parkway, Fort Walton Beach, Florida. ARMSTRONG was seated in the driver seat of the vehicle, and the vehicle was running.

After being removed from the vehicle, ARMSTRONG refused to provide his name and fled from the scene. After a short foot pursuit ARMSTRONG was apprehended. ARMSTRONG was subsequently taken into custody.

Contact was made with the GRANT via telephone and she identified she did not know a Lakeith ARMSTRONG.

The above was determined by visual and physical evidence.

Based on the above, your Affiant has probable cause to believe the defendant, Lakeith Jamar ARMSTRONG, did violate Florida State Statute 812.014(2c6): Grand Theft Auto.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

Deputy Sheriff Tyler Williamson, hereinafter referred to as your Affiant, is a sworn and bonded law enforcement officer. Your Affiant is currently employed by the Okaloosa County Sheriff's Office (OCSO), and has been so employed since January 2014. Your Affiant is currently assigned to the OCSO Field Services Division as a Deputy Sheriff. Your Affiant being duly sworn states as follows:

On 3/5/2018, Lakeith ARMSTORNG (Defendant) was found seated in the driver's seat of 2018 Toyota SUV, bearing Florida license plate ITUW47, which was identified as a stolen vehicle out of Okaloosa County, Florida. ARMSTRONG was located in the vehicle at 1096 Beal Parkway, Fort Walton Beach, Okaloosa County, Florida (Tom Thumb Gas Station).

ARMSTORNG was subsequently detained in handcuffs for a vehicle theft investigation by law enforcement, who were wearing their OCSO uniforms with their badges exposed.

During the investigation your Affiant, as well as other law enforcement officers, asked the defendant multiple times to provide his name, which he refused to do. ARMSTRONG was explained he could face criminal charges if he did not provide his name, but he continued to ignore the request for his information.

ARMSTRONG was relocated to an OCSO patrol vehicle where he was going to be secured. As your Affiant attempted to place ARMSTRONG in the vehicle, he forcefully pulled away breaking your Affiant's grasp. ARMSTRONG then fled on foot while handcuffed, refusing all verbal commands issued by your Affiant to stop. After a brief foot chase, ARMSTRONG fell in a wooded area and was subsequently taken into custody near Swan Lane, Fort Walton Beach, Okaloosa County, Florida.

During a search of the stolen vehicle, a black semi-auto handgun was located on the driver's seat where ARMSTRONG had previously been seated. The location of the firearm would've been readily accessible to ARMSTRONG while he was seated in the vehicle, and was concealed from view while ARMSTRONG was in the vehicle sitting on top of the firearm.

A criminal history inquiry was conducted which revealed ARMSTONG is/has been labeled a convicted felon as of 9/11/14.

Based on the facts your Affiant has reason to and does believe the defendant, Lakeith ARMSTRONG, was in violation of Florida State Statute 843.02 Obstructing Justice (2 Counts); Florida State Statute 790.01.2 Possession of a concealed weapon; Florida State Statute 790.23.1a Possession of a firearm/ammunition by a convicted felon.
