[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

I have just and reasonable grounds to believe, and do believe the above named defendant, Jamel Coleman, did commit the offense of F.S.S. 812.13(2a): Robbery with a Firearm. This incident occurred at 1992 US Highway 90 W, Crestview, Florida on March 8, 2018.

Okaloosa County Units responded to a Robbery in-progress call to the above location. Upon arrival, units made contact with store attendant [REDACTED] who provided a sworn affidavit of complaint indicating he was counting cigarettes and heard the front door open. When he turned around two young black males were in the store with one who jumped over the counter at register A (known as #1). The second came around the end of the counter by register B (known as #2). The suspect by register A had a gun. They told him to open both registers. They grabbed the money from both registers and ran out the door. They ran towards Antioch Road. They were wearing dark clothing, had their faces covered and wore sunglasses. When he got to the front door of the store to lock it, they were out of sight.

Witness [REDACTED] provided a sworn statement indicating at around 8:05 p.m., she and her EMS partner pulled up at the Tom Thumb Store located at PJ Adams and SR 85. She saw a black male with a neon yellow Capt D's shirt on in a baby blue 4-door car with 1 or 2 other passengers. She stated the car had a temporary paper tag and no dark tint on the windows. He checked out of the store while he was directly in front of her.

At around 11:25 p.m., she noticed the same car and same male was in the store at 1992 US Highway 90 W. She purchased a milk shake and went back to her truck. When she walked by the car there was no other passengers in the car. Once she got in the truck she did not notice anything else until the police arrived.

The defendant stated Post-Miranda that he was out with his friend he called "KG", later identified as

co-defendant Keyshan C. McClearn, and picked him up off P.J. Adams. The defendant stated he went to the Tom Thumbs at PJ Adams earlier to get some gas and something to eat. Then he stated they were riding around. The defendant was asked about the red back pack in his vehicle. The defendant stated it was "KG's" backpack. The defendant denied involvement in this incident.

I immediately view the surveillance video that showed the defendant coming into the store and walking around the counter to go to register 1. The video shows the defendant wearing croc-like shoes, gray pants and a lime-green shirt emanating from under a gray hoodie. The defendant was carrying a red in color back pack. The video also shows the defendant was the retrieving the money from both registers while the co-defendant, Keyshan C. McClearn, used a black in color semi-automatic pistol by pointing at the attendant towards his head and ordering the attendant to open the registers and moving him out of their way.

During contact with the defendant at Aplin Court Apartments, the defendant was wearing the same shoes, pants, and lime-green shirt as I saw on the video. While walking around the defendant's 2008 Ford 4-door bearing temporary Florida license tag CDN8819, I notice a red in color back pack in the open position with black in color clothing and gray in color clothing showing. Furthermore, I recovered a black in color Scgy CPX-2 semi-automatic 9mm pistol bearing serial number [REDACTED] with a fully loaded magazine containing 6 rounds, NFC Luger 9mm, from just underneath the vehicle by the rear driver side wheel. This weapon matches what I saw on the store's video surveillance.

Tom Thumbs Store audit representative, Sheri Lynn Edna Davis, arrived on scene and conducted an audit of register 1 and 2. She provided a sworn statement indicating the defendant stole \$62 from resgister 1 and \$29 from register 2. She concluded the total loss was \$91.

This incident occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.

At around 11:25 p.m., she noticed the same car and same male, codefendant Jamel Coleman, was in the store at 1992 US Highway 90 W. She purchased a milk shake and went back to her truck. When she walked by the car there was no other passengers in the car. Once she got in the truck she did not notice anything else until the police arrived.

The defendant stated Post-Miranda codefendant Jamel Coleman picked him up at a friends house off P.J. Adams. The defendant stated he went to the Tom Thumbs at PJ Adams earlier to get some gas and something to eat. Then he stated they were riding around. The defendant was asked about the red back pack in his vehicle. The defendant stated it was not his. I explained to him the codefendant Jamel Coleman stated it was the defendant's backpack. The defendant neither confirmed nor denied the item was his at this time. I asked the codefendant about the semi-automatic weapon that was found under the vehicle at the time of initial contact. The defendant stated, "Guns move all over Crestview." He denied knowledge of any weapon, and denied involvement in this incident. However, he did state codefendant Jamel Coleman picked him up earlier in the day and he has been with him the whole time.

I immediately view the surveillance video that showed the defendant coming into the store, with a firearm in his possession, and jumping the counter at register 1. I also noted the defendant was wearing baggie black in color sweat pants. The video showed the defendant, Keyshan C. McClearn, used a black in color semi-automatic pistol by pointing at the attendant towards his head and ordering the attendant to open both registers and moving him out of their way.

During contact with the defendant at Aplin Court Apartments, the defendant was wearing black baggie sweat pants and no shoes. While walking around the codefendant's 2008 Ford 4-door bearing temporary Florida license tag CDN8819, I notice a red in color back pack in the open position with black in color clothing and gray in color clothing showing. Furthermore, I recovered a black in color Sccy CPX-2 semi-automatic 9mm pistol bearing serial number [REDACTED] with a fully loaded magazine containing 6 rounds, NFC Luger 9mm, from just underneath the vehicle by the rear driver side wheel. This weapon matches what I saw on the store's video surveillance. During lawful detainment action of the defendant, the defendant tried to pull away from D/S J. Boggs by bending downward towards the rear driver side wheel.

Tom Thumbs Store audit representative, Sheri Lynn Edna Davis, arrived on scene and conducted an audit of register 1 and 2. She provided a sworn statement indicating the defendant stole \$62 from resgister 1 and \$29 from register 2. She concluded the total loss was \$91.

This incident occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
