[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On April 26, 2018, the 14 year old defendant, Ian Thomas Ray did commit the criminal offense of False Report About Planting a Bomb, Explosive, or Weapon of Mass Destruction, or Concerning the Use of Firearms in a Violent Manner.

On the above mentioned date, between the hours of 3:30 pm and 4:00 pm, while on Okaloosa County school bus 08-03, the defendant became engaged in a verbal altercation with another student about the type of music being played. During this altercation the defendant told the student that he was going to "Shoot up the school bus and Destin Middle School. The defendant also referenced a different student by name indicating that student was going to be his first target. The defendant told the students that he had a "Hit List" and named a third student that was on this list.

These statement from the defendant created extreme fear in the three students who witnessed this incident to which all of them have completed sworn written statements to the facts stated above.

This offense did occur in Okaloosa County and is a direct violation of F.S.S. 790.163 (1) False Report About Planting a Bomb, Explosive, or Weapon of Mass Destruction, or Concerning the Use of Firearms in a Violent Manner.
