[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On April 2, 2018, your Affiant responded to a noise complaint at 62 Terra Cotta, Destin, Florida.

While approaching the house in my patrol car I observed many individuals coming in and out of the residence. As I got closer on foot several individuals ran in the house and shut the door. I knocked on the door and rang the doorbell several times. Finally the door opened, I instantly smelled the odor of marijuana. I asked to speak to the person in charge and whose name was on the lease. At this point the door was wide open and I observed several locations of loose marijuana laying on the coffee table, as well as the kitchen table. There were also liqueur bottles and beer cans scattered around the house.

At this time D/S Williams made entry into the house and told everyone to go down stairs into the living room where we detained them. Upon further investigation only one person was found to be over the age of 21, Thomas Gardner, who was read Miranda and admitted he knew all the individuals were in high school, under the age of 21 and that they were drinking. He also said he was chaperoning the kids. Gardner failed to take reasonable steps to prevent the possession

or consumption of the alcoholic beverages by the minors and he is the adult chaperone for this residence.

Post Miranda Gardner Admitted to having a large bag of marijuana in a duffel bag upstairs in his bedroom, he showed me where it was and admitted it was his. The marijuana was less than 20 grams. The marijuana tested presumptive positive for the presence of THC.

Based on the information above I have reason to believe and do believe the defendant, Thomas Gardner, did violate F.S.S. 856.015 (2) to wit: open house party and 893.13(6)(B) poss. of marijuana less than 20 grams. These offenses occurred in Okaloosa County Florida, where I am a sworn Law Enforcement Officer.
