[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 04/03/2018, at approximately 1707 hours the defendant, Richard Xavier Abenojar, and a co-defendant were observed by the staff members at Okaloosa Youth Academy located at 4455 Straight Line Academy, Crestview, Florida, escaping the secure youth facility. The defendant and co-defendant were incarcerated at the secure youth facility on unrelated charges. The defendant and co-defendant were observed climbing the approximately 10-12 foot chain link fence of the secure youth facility and running along the fence line into the woods to the east of the secure facility. The staff was able to pursue the defendant Abenojar who was captured outside of the secure youth facility in the woods without permission. The defendant Abenojar was turned over to the Okaloosa County Sheriff's Office.

Based on the above facts I have reason to believe and do believe the defendant, Richard Xavier Abenojar, did, in fact, violate F.S.S. 985.721: Escapes from secure detention or residential commitment facility. The offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.

On 04/03/2018, at approximately 1707 hours the defendant, Nickolas Shoffner, and a co-defendant were observed by the staff members at Okaloosa Youth Academy located at 4455 Straight Line Academy, Crestview, Florida, escaping the secure youth facility. The defendant and co-defendant were incarcerated at the secure youth facility on unrelated charges. The defendant and co-defendant were observed climbing the approximately 10-12 foot chain link fence of the secure youth facility and running along the fence line into the woods to the east of the secure facility. The staff was able to pursue the co-defendant who was captured outside of the secure youth facility in the woods without permission. The defendant Shoffner was later captured at the McDonald's on S. Ferdon Blvd, Crestview.

Based on the above facts I have reason to believe and do believe the defendant, Nickolas Shoffner, did, in fact, violate F.S.S. 985.721: Escape from secure detention or residential commitment facility. The offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
