#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On April 5, 2018, your Affiant responded to a noise complaint at 97 Shirah Street, Destin, Florida.

While approaching the residence in my patrol car, I heard loud music and yelling coming from the rear of the residence. Upon arrival, I attempted contact with at the residence with no avail. There was an open gate on the north side of the residence where I was able to observe a large group from the sidewalk that appeared to be under the age of 21 playing games involving alcohol as well as marijuana all in plain view. One of the females was observed to be 17 years of age in possession of alcohol. There were also liqueur bottles and beer cans scattered around the back yard.

Upon further investigation only one person was found to be over the age of 21, John Scallan. Post Miranda, Scallan admitted he knew some of the individuals were in high school, under the age of 21 and that they were drinking as well as the using of marijuana. He also said he was chaperoning the kids. Gardner failed to take reasonable steps to prevent the possession or consumption of the alcoholic beverages by the minors and he is the adult chaperone for this residence.

Based on the information above I have reason to believe and do believe the defendant, John Scallan, did violate F.S.S. 856.015 (2) to wit: open house party. This offense occurred in Okaloosa County Florida, where I am a sworn Law Enforcement Officer.
